Mr. Cieszkowski said the Master Plan Update Community Forum had been schedule for Thursday, August 3, 2023 at City Hall from 5-8 p.m. as an open house type meeting. He had distributed an email to all of Council regarding this Community Forum. He asked that the notice be shared on social media. There had been a Master Plan Update survey done last month that received 909 responses, but he hoped this Community Forum would provide even more public input. Mr. Ring noted that no more than three Council Members should attend this Forum discussing the future of Streetsboro to adhere to the Sunshine Law.

Mrs. Kremer shared a "human interest" item. Twenty-three years ago today was also a Monday Council Meeting night (July 10, 2000) and she had missed the Council meeting that night because her daughter, Ashleigh, was born that day and Mrs. Kremer's sister had come to the Council meeting that night to share pictures of the new baby girl. Council Members wished Ashleigh a Happy Birthday.

Chief Reinholz said Capt. Grimm had distributed the activity report. The Fire Department had "Fun in the Mud" at Tinkers Creek Chapel. The July 4th fireworks at Woodside Lake Park were very nice this year. July 8 was the Junior Baseball Awards ceremony and a fire truck was present for a "touch a truck" opportunity. The Department had been very busy with a lot of call, and there had been a lot of training this summer. There had been no firework-related injury calls this year.

Chief Wain said there were a few firework-related calls to the Police Department, but nothing too drastic. After a long process, the Police Department was now able to do lateral transfers between departments after a minimum of one year of police work. There were two positions open and the Streetsboro Police Department would take applications until July 21, 2023. The salary range would go along with time served. They were also starting interviews for entry level candidates. The police officer hiring process was not quick and had many steps.

Mr. Czekaj reported that the paving in the Stonegate development was wrapping up and Perrin had done a spectacular job. John Wood, our on-site inspector, also did a great job. The Miracle Lane Culvert Replacement project just had the wing walls poured walls and would finish soon.
