Mayor Broska explained that when the administration was considering the condition of the building at 525 Frost Road for possible purchase as a City Hall, they learned that the furniture in the building was unwanted by the owner of the building and if the City bought the building the furniture would all come with it. The City decided not to buy the building. The administration had been looking into getting new furniture for the Mayor's Office and his assistant's office

because their office furniture was quite old, so they asked if they could have two offices worth of furniture and Al Krist agreed. The Mayor and his assistant picked out the pieces they needed and the Service Department was able to move it and install it at City Hall, all for free.

Liquor License Request of Zip City/Laser Defense

Liquor License Request of Zip City/Laser Defense

Mrs. Kremer said these were received in the mail. The first one for liquor permit classes D1, D2, and D3 per the TREX was received in time to go into the packets. The second one for liquor permit class D3A was received the day after the packets were distributed and given to Council tonight. Council needed to indicate if they wanted to request the State hold a hearing on these permits or not. Mr. Ring looked up the permit classes and explained that D3A was a sub of D3 and allowed permit privileges until 2:30 a.m. (instead of 1 a.m.). Mayor Broska clarified that D1 was for beer, D2 was for wine and mixed beverages, and D3 was for spiritous liquor.

Mr. O'Malia found an email from the business owner that stated he was planning three bartenders and six servers. The owner also stated a retired policeman would be on site as well as two more managers, they would not start serving alcohol until 5 p.m. and Mr. O'Malia did not expect the indoor shooting-type range would be going until 2:30 a.m. It would be simulated shooting at targets with CO₂ canisters and lasers, but no bullets.

Liquor License Request of Another Broken Egg Café

Mrs. Kremer said this had also come in the mail for a D5I liquor license permit and Council needed to indicate if they wanted a State hearing on this license or not. D5I was for spirituous liquor for on premises consumption only, beer, wine and mixed beverages for on premises, or off premises in original sealed containers, until 2:30 a.m. for restaurants meeting certain criteria (building size, seats, parking spots, community population, etc.). Mr. Ring noticed that any licenses under D5 with a letter did not count toward the quota, so Mr. O'Malia may be able to use that option in his negotiations with businesses. Streetsboro had already reached its quota of 9 D5 licenses, but this other option might be able to help Mr. O'Malia. Another Broken Egg Café was planning to go into the old IHOP building off Singletary Drive.
