Reports/Communications from Depts/Boards/Commissions

Mr. Mytinger gave an update on the Parks and Recreation Department: the Fall Program Guide would be distributed this week; October 14, 2023 will be the Leadership Portage County Beer Fest at City Park along with a Pickleball Tournament; the new pickleball courts were getting a lot of use; Trunk or Treat will be Thursday night, October 19, 2023 6-8 p.m. at City Park; the new Community Center building had a roof and interior walls would start soon.

Chief Reinholz said the weekly activity report had been distributed. Last Thursday was very busy with a fire in the morning where four dogs and two cats perished, and the storm that night with a lot of trees and wires down. The City of Hudson tornado sirens went off Thursday night and a lot of people from the KOA campground and some from Camelot went to the fire station for shelter. The new fire station has a mandated shelter/bunker area to shelter the fire service personnel during a tornado so they will be able to respond after the storm, so the citizens that arrived were welcomed into the shelter until the danger had passed, but the shelter is not large enough to house the community. KOA has a contingency plan to shelter at the church across the street, but no one was at the church to unlock it at midnight, so the citizens came to the fire station for help. Chief Reinholz said the Fire Department was still waiting to hear about grants. On Sunday a mom and her 4 ½ years ago. Friday, September 1, would be the first SHS home football game for the season and the squad would be there. October 27, 2020 would be an active shooter live drill with the County and City safety forces and the Fire Department had been preparing/training with the Police Department for the drill.

Mayor's Report

Mayor Broska said after the storm on Thursday night the Service Department had two crews out this week doing brush pick up for the storm damage brush. The normal brush pick would still be done in September. Mayor Broska thought the electric service that was lost during the storm had now been restored to everyone in Streetsboro; his home in the SE part of town had power restored Sunday night about 9:30 p.m.

Mayor Broska reported that the Engineering Department had reviewed the punch list with Shelly for the completion of SR 14, but the road has been open to traffic.

President of Council's Comments

Mr. Hannan thanked all the staff that worked hard to take care of the City during and after the recent storm to make sure everyone was safe and that all the trees and wires got cleaned up.

Council Members' Comments

Mrs. Field commented that the tornado sirens worked Thursday night. She remembered that City Council had discussed tornado sirens years ago and realized they were very expensive, but everyone she talked to this week said they heard the sirens which woke them up, not their phones. Mayor Broska said another thing that works is a \$12 weather radio alert system from National Weather Service that you can keep in the bedroom that only goes off when there is a weather emergency. On Thursday night his phone went off with a tornado warning alert and woke him up. He said with the technology that is available, if people want to hear the sirens, they can buy a \$10-\$12 weather radio instead of the City spending hundreds of thousands of dollars on tornado sirens. Mrs. Field said she was not suggesting the City buy sirens; she was just reporting that's what worked.

Ms. Glenn thanked Mr. Czekaj for giving her a tour of the Community Center that was under construction. She appreciated seeing the progress.

Mr. Lombardo thanked the department heads that handled the water meter replacement project because he understood they put a lot of effort into it and that showed they cared about moving the City forward. He also thanked the departments that were handling the storm aftermath/clean up.
