Reports/Communications from Depts/Boards/Commissions

Mr. O'Malia reported that previously he had announced that a German manufacturer was considering the JEDD. They are a manufacturer of copper fittings used in plumbing applications. They recently closed on 80 acres within the JEDD and phase 1 would create 65 jobs, which could net Streetsboro about \$20,000/year and about \$44,000/year for Shalersville and another \$7,500 for the JEDD's infrastructure. There was a petition for the German manufacturer to join the JEDD. In order for them to receive tax abatement Streetsboro wanted them to pay income taxes and join the JEDD. By law the City needed to schedule a 30-day public notice so anyone could come in to review the application. The Shalersville Trustees would hold a public hearing on the matter on January 2, 2024 and Streetsboro would like to hold their public hearing on the matter on January 8, 2024, the first Council Meeting of 2024.

Mr. Mytinger reported the Holiday Lighting ceremony would be this Thursday, December 7, 2023 at 6:15 p.m. at public square and then cookies and stories with Santa Claus and Mrs. Claus at the fire station. He asked everyone to be careful parking because of the City Center construction zone near the fire station. He said the Community Center construction in City Park was coming along very well.

Chief Reinholz said there would be a live burn on Thursday with Tri-C, then the Holiday Lighting and Santa at the fire station in the evening. There had been two fires in the last two weeks. One in Kent on Thanksgiving Day without much damage to the house. The Fire Department had been

notified that they had been awarded a \$3,000 BWC grant toward a LUCAS machine and would bring the paperwork to Council once the details had been worked out. The department currently had one LUCAS machine for each squad and was working to replace each one over time with updated versions; They were about \$15,000 each. They were doing fall housecleaning and regular training sessions at the station this month.

Chief Wain said Shop With A Cop was going to be on Saturday, December 9, 2023 starting at 9 a.m. and they were looking for additional adult volunteers to help with the program. Twinsburg PD would join in the event and it would start with a gathering at the Middle School and then caravan to Walmart who had given a generous grant that would help about 25 kids to join the program, then go to Dairy Queen for a provided lunch, and finish back at the Middle School.

Mr. Czekaj said the City Center electrical conduit installation had begun. The mound that had been created was more than could be mowed, so he was discussing with the contractor to truck some of it off site in the spring under a line item that was already in the contract. Mr. Czekaj also noted that the RFQ had been distributed for the Construction Manager at Risk (CMR) for the new City Hall and expected quite a few responses by the December 6, 2023 deadline.

Bill Miller confirmed the Service Department was prepped for this year's snowstorms, even the one expected tonight.
