**T-7500 Resolution Appointing and Confirming Department Heads**

Mr. Michniak said this was a special event tonight. He felt that the Mayor had put together a strong team and he felt that the residents and Council Members were amazed at how professional they all were and how well they did their jobs. Mr. Michniak said he worked at the County level and knew that the general reputation of Streetsboro had changed at the County level and Streetsboro was now known as the city that "had it's shit together." He said Streetsboro was an example to the rest of the County for the successes and growth it was having over the last few years. He added the commercial businesses and tax base at Streetsboro and a few of the other cities were what carried the County budget. As a resident and as a Council Member Mr. Michniak was proud of the administration. He said the credit went to Mayor Broska for putting together the team. He said it was a pleasure to work with all the department heads to be reappointed tonight. He knew they all acted in the best interest of the City.
