ROAD CONSTRUCTION BEGINNING



Attention Motorists: Roadwork will be under way on NW 50th Street between North Meridian Ave going west to North Redmond Ave and will be under construction for approximately one month to overlay all four lanes with 2 inches of asphalt and to install school zone safety

improvements such as marked pedestrian crosswalks and installation of in-pavement flashing lights for active school zones.

REGISTER YOUR STORM SHELTER - Citizens are reminded to register their storm shelter with the Warr Acres Police Department. In the event of a tornado and you become trapped in your storm shelter, it's imperative that rescue services know the location of your shelter to implement the most efficient search possible of affected areas.

We are currently following a mandatory odd/even watering system. If your address ends in an even number, you can water on even-numbered calendar days. HOUSEHOLD HAZARDOUS WASTE COLLECTION

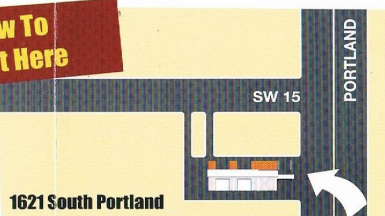
1621 SOUTH PORTLAND

Storm Safety

HAVE A SAFETY PLAN:

- Have a safety plan for wherever you might be when a tornado strikes – School, work, church, home, shopping, etc.
- Think through your plan in advance, since there may not be much time to act once the tornado is approaching you.
- Practice your plan and be sure all family members know what to do.
- City offices are **LOCKED** during a tornado warning.

JULY IS RESIDENTIAL * BIG TRASH PICKUP MONTH

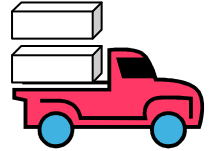
Items must **NOT** be placed out for collection earlier than four (4) days preceding the regular scheduled big trash collection day.

Ward 1 – Wednesday, July 09
Ward 2 – Wednesday, July 16
Ward 3 – Wednesday, July 23
Ward 4 – Wednesday, July 30

Big Trash **INCLUDES**, but is not limited to: household appliances, furniture, carpet, mattresses, box springs, water tanks, fencing (up to 4 panels) and similar non-contracted items, bagged grass, and brush produced as refuse from single-family dwellings. Compressors must be removed from all appliances **BEFORE** collection may be completed. Doors on refrigerators and other bulky items **MUST** be removed before placement on curb.

Items **EXCLUDED** under the definition of big trash include hospital and medical waste, poisons, acids and caustics, explosives, dirt and rocks, sewage and liquid waste, nuclear materials, gasoline, kerosene, propane tanks, degreasers, lubricants, tires and rims, antifreeze, paint, and commercial construction debris, bricks or concrete. Call sanitation at 491-6474 if you have any questions.

SIZE OF MATERIAL: Big trash shall be a length not exceeding 10 feet or a weight exceeding 250 pounds. Tree trimmings and branches must be placed together in piles with individual branches not longer than 8 feet and dead trees (not more than 6 inches in diameter).

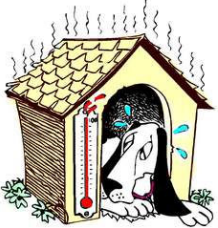


The **TOTAL** amount allowed at the curb is 8 cubic yards (equal to what you can place in the back of 2 full size pickup beds level with the top of the cab).

PLACEMENT AND LOCATION of big trash: Items shall be placed at least five feet (5') from mailboxes, cars, shrubs, or anything else that could interfere with hand loading or mechanical equipment.

Items shall be placed at least ten feet (10') away from utility poles, guywires, signs, fire hydrants and gas meters to allow mechanized pick up. **RESIDENTIAL is defined as a SINGLE FAMILY home OR a duplex.*

DOG DAYS OF SUMMER. Hot weather poses special risks for your dog. **NEVER, EVER** leave a dog unattended in a vehicle in the summer months. The temperature inside a car can rise to over 100 degrees in a matter minutes, causing heatstroke and death.



Doghouses and dog crates are **NOT** good shelter during the summer as they can trap heat. You may want to fill a child's wading pool with fresh water for your dog to cool off in. Always provide plenty of cool, fresh water. Help keep the drinking water cool by placing a soft drink bottle filled with frozen water in the water bowl. Try to avoid prolonged exposure to hot asphalt or sand, which can burn your dog's paws.

Short-faced dogs such as Boston Terriers, bulldogs, and boxers have an especially hard time in the heat because they do not pant as efficiently as longer-faced dogs. If possible, keep these dogs in air conditioning.

ASK TO SEE ID WHEN SOMEONE COMES TO YOUR DOOR claiming to be a representative of a utility company or repair service:



- 1) **DO NOT** volunteer any information about how many people are in the house. If they are there to burglarize, they will want to find out if you are the only one at home.
- 2) **ALWAYS** ask to see a badge. **ALL** OG&E employees have one. Contractors will not, but **ALWAYS CALL** OG&E at (405) 272-9741 to verify if they were sent by the utility company.
- 3) If you're truly uncomfortable, call the police.
