Deputy Chief Osborn said that Chief Patty was still out with family health issues. He said he wanted to thank the Street Department for the great job they did clearing the streets after the winter storm, it really helped them be able to get around town.

Chief Koger said they have been hosting groups of kids with cancer and it has been a great experience. The IAFF buys t-shirts for the kids that are like the ones the firemen wear.

Clerk Ramirez said that she was in the city's bank account taking care of business and discovered 4 items that had hit the account that were fraudulent, she contacted the bank they immediately put a hold on the account. She also spoke with the Attorney, Mayor and Deputy Chief and there is an investigation underway. Councilman Fuhrman asked about the tax audits that were being done. Clerk Ramirez stated that the one on the Heat and Air business they told her was fine and nothing to report. The other large company is ongoing and they have found some things.

Mayor Woolley stated that the city crews did a great job salting and sanding streets and it made it easier for the police and fire to get where they needed to be. He said they did a great job and he received an email thanking the city that said the surrounding cities did not do a very good job and they were happy Warr Acres did.

PWD Turman thanked the council for purchasing the equipment that was used for the storm he said it made everything run more efficiently. He said Alfredo's recently opened. They used the street sweeper until it got too cold to spray water. Councilman McClure asked if the city dropped the ball on another CDBG grant and he was told that you have to have one closed before you can apply for another one and there is more information that DEQ is now requesting so it does not look like there will be a grant for 2014.

Engineer Wallace said that the sidewalk project is on track for 2015, and the South MacArthur project is set for 2016 and a couple of the current projects will be let at the first of the year. He said the city has done a great job of spending other entities money.

Planning Commission Chairman Wehba said that they did not have a meeting this month because the date on the agenda was incorrect.

They explained how the funding program worked and that without the resolution they could not apply.

Godwin reported that ACOG has several committees and they have money available for things like bike paths or park upgrades and the city should apply for some of the funding.

Maxey said a big thank you to the ladies that redid the Christmas decorations they look great.

Fuhrman said he would like to see the city apply for the bike route funding.

Shapiro said he appreciated the time and effort Councilman Godwin is putting in with ACOG and that he reports back to the council the information he receives that has not been the case in the past. He said he understands that Deputy Chief Osborn has really stepped up with the Chief being out and he appreciated everything he has been doing. He then stated that he was embarrassed at the way item 16 was handled and that questioning and discussion continued to go on after the vote was taken. Parliamentary procedure was broken and after the item was voted on they should have moved on to the next item not continued to discuss it. He also was frustrated that the item was done and closed and that he did not appreciate that someone wanted to know why he voted the way he did. He

said he served for years dealing with the arguing amongst the council and he won't have it again. When an item is voted on it is done and should not question the others votes. Councilman Fuhrman stated that he asked if it would be proper to ask the ones that voted no why they did and the Attorney said he could ask but that did not mean he would get an answer. Councilman Shapiro stated that he should not have even asked.

Mayor Woolley said that he was sorry he should have stopped the conversation after the vote. He thanked the street crews for the work they did during the storm and Deputy Chief Osborn. He said he feels like the current council is one that wants to see the city move forward and appreciates all of them.
