Patty-the department started using the DigiTicket system last week.

Koger-the department broke the 3 minute response time again and they have started handing out comment cards to see how the citizens believe they are doing on calls.

Love-welcome to the new councilmen and if they have any questions do not hesitate to call. He said the Comprehensive Plan for new zoning is ready for the council to hear and over the next several months they will be having hearings.

Turman-the City Hall Energy project is almost complete. The 50<sup>th</sup> and MacArthur project is ready for right of way acquisitions and the Federal money the city has will be able to be used to bury the cables at 50<sup>th</sup> and Mac to make it more eye appealing. He has spoken to a couple of architects on the ACO building and will have information for the council next month. He thanked all the Public Works employees for their hard work. OG&E is putting in new poles along 63<sup>rd</sup>.

Rice-Comprehensive plan is ready for the council to look at and hold hearings. They will be setting policies and guidelines for the future development of the city.

9. A. Discussion and possible action on an Ordinance amending 2.05.010 pertaining to item submittal for the City Council agenda. \*\*\*\*

The Mayor read a memo that he had passed out before the meeting stating that originally they had put that three members were needed to place an item on the agenda and after speaking with some councilmembers and hearing their concerns decided to change it to two members. There was concern raised that if a member wanted an item on the agenda and had to find others to agree that it was something worthy of being on the agenda for all to consider then they would be breaking open meeting laws by, some felt polling the other members to get approval to go on the agenda. Attorney Love stated that they would be asking if someone thought the idea was agenda worthy not if they would vote for approval of the item. After a lengthy discussion there was still concern about getting others approval to place an item on the agenda.
