1. Call to order, Declaration of a quorum, Flag salute and Invocation by Trail Life USA Troop OK-63 from Cherokee Hills Christian Church and Leader Tim Tardibono.

Mayor Woolley called the meeting to order, declared a quorum present, and the Trail Life USA Troop OK-63 led everyone in the Flag Salute and the Invocation.

Councilman Godwin entered meeting at 6:05 p.m.

2. Call to the Public.

Barbara Harris, 5917 N. W. 43rd, wanted an update on the animal shelter.

Jan Blake, 5603 N. W. 37th, also wanted an update on the animal shelter. Jan also stated she would like to see more public relations about the City of Warr Acres in the newspaper.

Mayor Woolley stated that the architect that wrote up the specifications for the animal shelter was no longer with the City. He stated, hopefully, that progress would be started for the animal shelter within the next 10-12 months. Mayor Woolley also stated that he was talking with Zach Jacobs about writing articles for the City to be put in the newspaper.

Police Chief Patty stated that there was a facebook page that was being worked on for the City in order to put pictures of animals so that citizens could look at to help with animal adoptions.

Mike Turman stated that although the Council had approved the budget for a tractor/box blade, it was more important at this time to buy a Dixie Chopper and a new snow plow. The snow plow was damaged last winter and needed to be replaced.

Councilman Fuhrman stated he felt the numbering of the Chapter/Section should be 19.12. instead of the 19.20.

Proposal No. 1 and Proposal No. 2 will need to go back to the Planning Commission for review and change the number to 19.12.020, etc. (.12 to be inserted instead of the incorrect .20). This will then come back before the City Council for approval.
