Turman-the street crews are ready to go as soon as the weather moves in. The new car wash is coming along, as well as the new office building and more homes in Cherokee Crossing. He has been short staffed with people out sick and also had some equipment down.

Wallace-south MacArthur project has been approved for 2019 funding and sometime September 2019-January 2020 there will be a letting for the project. The project at 50th and MacArthur intersection has won 1st place by the American Concrete Paving Association.

He feels like that it causes broken relationships between the residents and the police. He said they drove around looking at areas where people park on the grass. Right now, if a car is in front of the house it is handled by the Police if it is behind the front line of the house it is handled by Code Enforcement. One problem with switching from Police to Code Enforcement is that the cars are not there during the day and Code Enforcement hours are 7-4. There will be something put in the next newsletter addressing parking in the grass and a potential a \$200 fine.
