5. Receive reports from Staff: Police Chief, Fire Chief, City Clerk, City Attorney, Public Works Director, City Engineer, City Planner, Projects Architect. ****

Chief Patty-said that last week former Police Chief Bobby Barnes passed away he was Chief from 1957-1960.

Chief Coy-Bethany has changed they way they respond to the Nursing Home calls and it has really cut back on runs so he will be looking at how we do it. Councilman Woolley stated that he thought it said a lot about the quality of our Fire Department with the ISO

rating the same of the last few years and that our Chief's have each been named Presidents of the Metro Associations.

Architect Rhodes-presented preliminary exterior drawings and floor plans and how each would be laid out on the properties for the Police, Fire and Animal Control facilities. He talked about the meetings he had with both Chief as to needs and wants and these are the first drawings. They will meet again to make changes. The talked about the fact that City Hall/Chambers project was 99% complete and there are items on the agenda to approve designs for IT, AV, Access Control and Security that will all need to be done and then worked into the plans and changes if needed will be done. The next item on the agenda is to hire a Construction Manager and he asked to move to that item so he could explain the next steps in the process for the City Hall/Chamber project.

6. Discussion and possible action on a recommendation by the Construction Management Selection Committee to contract with Lingo Construction Services to provide Construction Management services for the three Bond building projects as well as the CIP City Hall/Chamber project. ****

Troy Rhodes told the council that there were request for qualifications sent out, 5 companies responded, the selection committee reviewed and scored the companies and there were 2 that were way above the other 3 so those two companies were interviewed. There was much discussion on the 2 companies and a decision was made to recommend Lingo to the council to provide Construction Management services for all the Bond building projects as well as the City Hall project. Lingo was the only company that took the time to go to each of the sites beforehand. Mr. Stan Lingo addressed the council stating they have repeat clients for new projects and that this is the best way to show others they are a good business to work with. Councilman Woolley asked what they had done in the area. Mr. Lingo stated that they are working on the Capps Middle School, they have done several jobs for Dr. Evans, one of them is the Dental office on NW Expressway, several projects for Bethany Public Schools and Southern Nazarene University. He said they will take the plans from Mr. Rhodes analysis them and prepare a budget, then a review of where they are and where they need to be as far as the city's budgets will be done, if needed they will make adjustments and revise the budget numbers. Then after the budget is finalized, they will bid out the sub-contractor jobs, open, review and give details as to why each contractor was recommend if they were not the lowest bidder. Lingo does not get paid until construction of each area is complete, he gave an example of the slab getting poured then they will be submitting for their payment when it is completed. They will provide backup documentation for all cost. They will also put together a schedule for the work to be accomplished. He told the council that the team is already together and that he and JP Craig are the pre-construction team and that JP was chosen because he has architectural back ground as well as construction. John Schaffner is the project manager and is currently the manager for the Capps Middle School and Frank Falsarella is the superintendent for the Warr Acres projects. He said that since the City Hall and Animal Control will be going around the same time, they may bid some of the things together for both projects to see if can get a better deal, since the Animal Control project is so small.

7. Discussion and possible action on a contract with Pinnacle Consulting Management Group for property acquisition services related to the South MacArthur Project. ****

Aaron with Pinnacle was present to answer questions. He told the council that Pinnacle had worked with the city on the 50th and MacArthur project also. He stated there are 25 temporary, 20 permanent right-of-way's and there are 33 different owners. He is working closely with Craig since the project is set for letting in September, they will need to get all the right-of-way's taken care of by April. He said that all State, Federal and Local rules will be followed.

Mr. Myers with United Systems and Mr. Dillard with Security Systems were both present to answer any questions. Troy Rhodes explained that there are 6 systems that will need to be designed for the building, Fire Suppression, Lighting, IT, Access Control, Intrusion/Security and A/V. He will be doing the Fire and Lighting but these two

companies will handle the others. He stated that the plans are 99% complete what he needs to finish them is these other system designs.

Monies to come from CIP as per the 2020 budget. All vehicles to be purchased from the Kansas Highway Patrol. *Patty*

Evans-wanted to know if there was an update on the building at 46th and MacArthur. Said not all the windows were installed. Mayor Mickley stated the last he heard that they were looking for tenants and had upgrade as much as they could for now.

Allsup-she was very upset about all the negative things being posted on the Nextdoor media site by people that do not call and find out the correct information. She asked the public to call and find out about things and not believe everything they see posted. She asked the public to get involved in the city.

Lipinski-the last month has been an eye-opening experience with the postings and he has tried to clarify facts that are not correct. He stated that he has defended city staff that have had ugly things said about them. He also said the he looked up properties in county records that were similar to his but were located in OKC to see how the taxes compared. He said that they were pretty much the same and sometimes this is want it takes to run a city.

Godwin-first rule of social media is Do Not Read It. As far as the \$7 increase in the Sanitation rate the council had to do what needed to be done to keep the city running. Congrats to Chief Coy and Chief Mahaffey.

Knipp-stated he didn't think most people do surveys and they like the service they get and the \$7 wasn't that big of a deal. He said the people voted to approve the bonds, the city asked them and they approved it. Congratulation to Chief Coy and Chief Mahaffey on their appointments as Presidents of the Metro Chief's Association and Metro Area Fire Instructors Association.

Mickley-appreciates everyone voting for the contractors. He said it is very exciting time for Warr Acres. He also stated that he hoped would be able to give them some good news in relation to Economic Development soon.
