Love-wrongful death case dismissed, and State Supreme court ruled in favor of a city in a marijuana case today which will help in the SW Builders' case.

Turman-paving on NW Expressway done and to Wilshire on MacArthur.

Wallace-ACOG applications for projects due and they will again be submitting for the light on 63rd for the school.
