5. Receive reports from Staff: Police Chief, Fire Chief, City Clerk, City Attorney, Public Works Director, City Engineer, City Planner, Projects Architect. ****

Ramirez-stated that as soon as she could get back in the office, she would get them the monthly reports.

Turman-you all know we had a ice storm and we are working with some companies to figure out the best way to dispose of all the limbs, it will most likely take a month or more. They have been talking to Mr. Meek about on option of using his land to store the limbs and then shred and take to the landfill, another option would be to collect the limbs and take them straight to the landfill, they will choose the most economical option.

Wallace-residential street work continues, only missed when the ice storm came. South MacArthur utility location work is continuing, and ONG is the last to relocate. Councilman Woolley asked if there had been any word from Oklahoma City in helping with Wilshire overlay. Mr. Wallace stated that as he had stated a couple of meeting ago, Oklahoma City has budgeted funds for work on Wilshire, Grove and some at 36th and

MacArthur. Councilman Knipp asked about the intersection of MacArthur and 39th and if they had spoken to ODOT. Mr. Wallace stated that they have and also have given them the traffic study that was done in 2017 and told them what they feel is the best option.

Rhodes-showed pictures from the New City Hall exterior and interior and told the council that the punch list for both inside and out have been done and final work is being completed. He stated that the low voltage work is underway. He showed picture of the Animal Control Shelter and it is nearing completion. The Police Department work is underway and it is hard to see the progress because most work is underground, but they are progressing in a timely manner even with the weather disruption. The Fire Department of course can not get underway until City Hall has moved but they are hoping by the end of December if not early January

The applicant stated that he plans on making the property look very nice and put some nice landscaping in. Councilman Woolley

stated that he was glad the old buildings on the property were gone and glad to have something new there. Mayor Mickley told Mr. Allen that he could not block the alley.

9. Discussion and possible action to authorize the Mayor to negotiate and execute an agreement with Oklahoma Land Development Group LLC to obtain temporary use of the Group's property for the storage of tree limbs and debris and to engage in disposal activities for the limbs and debris. ****

PWD Turman and the Mayor have been talking with Mr. Meek about the use of some of his land to store limbs until they can dispose of them. This would be at no charge.

10. Discussion regarding City's contract for EMS Service for Fiscal Year 2021, including discussion on the rates charged to utility customers to cover the cost of the contract.

The Mayor told the council that current contract is with Samaritan, however they have been bought out by Pafford and due to the increase in expenses for the ambulance service caused by COVID they want to raise the rate from \$135,000 to \$175,000. This would cause the city not to be able to cover the cost for ambulance service unless the city implements an increase to the ambulance fee charged to utility customers. The fee would need to be raised by \$1.15 to cover the cost. Mr. Hobbs, Pafford operating officer, thanked the council for allowing them to be present to answer any questions. He stated that they are in the works of purchasing a new unit and some other things that will help them better serve the city. He thanked the for the opportunity to sever Warr Acres.

11. Presentation and discussion on Fiscal Year 2021 Budget for the City of Warr Acres. ****

Clerk/Treasurer Ramirez stated that this is the 2020 budget with dates changed and only a few minor changes based on items that must be carried to certain account. She stated that as required by law she must present them with a budget document before December 1st and since meeting are in limbo currently she had to give them one with no step raises or line item changes as requested by the Department Heads. She told the council that we are waiting for the COVID Cares Act money and as soon as that money hits the bank she can make the changes to the budget, the salaries, insurance and line item changes requested by the Department Heads, and sent it out to them. She did not feel it was right to send out a document that had the money showing when we did not yet have it. She told them by law they are required to hold a public hearing on the budget before the 15th of December and that is the day of the next council meeting. She asked them to please carefully review the budget when they receive the updated one so they can call and ask questions or let her know if something does not look right. Normally, the council approves the budget the night of the hearing.

13. A. Discussion and possible action on an Ordinance amending 6.12.020 related to requirements for non-residents to seek the return of a dog which has been impounded by Warr Acres. *Mickley* ****

The Mayor stated that the Cherokee Hills Veterinary clinic had brought to his attention the fact that every other city has a requirement of a 3 years rabies vaccine, however, Warr Acres does not. The Warr Acres code did not specify for resident a 1 or 3 year vaccine, but for non-residents that have their pet picked up in Warr Acres they are required to

show proof of a 1 year vaccine. They asked if that could get changed to a 3 year like every other city. He asked Matt to draw up the Ordinance for the council to consider.

Motion by Allsup, second by Von Thaer to approve the Ordinance related to non-residents rabies vaccine proof when seeking the return of their animal. Poll vote: Von Thaer, yea; Woolley, yea; Allsup yea; Knipp, yea; Lipinski, yea; and Mickley, yea.
