Craig- This is part of the widening of MacArthur to 63rd St. The City wanted to upgrade the street lighting to the antique, as part of the ODOT contract. All the footings and conduit were installed as part of the project. OGE inspected those footings and light poles where they would be, the power was at 42nd St North, and the footing, at 43rd doesn't have conduit that connects to 42nd St. They need that conduit in order to power at 42nd St where the transformer is and the electrical power comes from for the street lighting and it wasn't in this plan. This proposal from Traffic Signals Inc. who is the maintenance contractor and was the subcontractor for Schwartz is holding his pricing considering how long ago the job was bid. His estimate was based on the contract pricing to install the conduit so OGE can pull the electrical power from 42nd St.
