 - E&D is usually \$50,000. Will be swapped with rural aid \$50,000

- Report from Mahar Representatives
 - Student representative reported the electronic pass system is working well

H. May Items

- BRYT program MOA Discussion and Vote
 - Bridging resilient youth in transition
 - Students needing tier 3 (highest need students); SELI specific, but benefits all students
 - It will not cost the school as it is fully grant-funded
 - Will supply materials such as flexible seating and all professional development
 - After the vote, there will be two meetings to look at supports in Tier 1 and 2 and where BRYT will fit with Tier 3
 - After the grant ends, what will the transition steps be?
 - Swift River potentially has the right place staffing-wise to continue the program
 - Year 1 = 100% covered
 - Slowly puts the cost on the school after
 - What is the cost after the first year?
 - It depends on the planning and will be better understood after the planning meeting
 - There may be a fee for professional services from BRYT
 - Range of \$6-13,000 per year
 - Small schools in a district have shared the cost in the past
 - BRYT wants to make this work for Erving and Swift River
 - If, after the planning phase, it is decided that this program is not feasible, it is fine, and there will be no cost to the school
 - Will the work to enact the program be added to someone's existing workload?
 - The academic coordinator already acts in the role that would align with BRYT
 - The question is there a person who can take on the mental health load and be the 'wrap-around' person
 - Erving has agreed to their MOA and has moved into scheduling the planning

- Is the vote just a show of support for conducting the planning?
