## D. Superintendent's Report

- 2023 Student activity plan
  - The Student Opportunity Act calls for every district and charter school in the state to develop
    3-year plans, referred to as SOA plans on round 2 of Student Activity Plan Act
  - Identify where data reveals disparities and describe how they will utilize evidence-based approaches and strategies to address those disparities
  - Fouced on evidence based stradigies and outcomes
  - Critical actional, evidence based stradiges are focused on rapidly improving outcomes for students with low academic performance
  - Plan must be submitted by April 1
  - Massachusetts Literacy grant meets as an approved
- DESE seeking changes in accountability
  - The increasing weight of chronic absentees
  - Three years of data
  - o Details are available in the summary of district and school accountability for public
  - DESE is seeking feedback
  - The committee can send a letter, but there is no form to complete

#### E. Director of Finance and Operations Report

- o FY25 Draft Budget Discussion
  - The Treasurer has taken on additional roles and responsibilities. Budgeting to reflect this increase in workload. This is reflected in the job audit done on the responsibility of the Treasurer
  - Administration lines are set for U28
  - Increase in financial audit
  - Higher prices of supplies have caused an increase in
  - Necessary ELL teacher
  - ESSER 1 and 2 funding for adjustment counselor is ending, and salary will move to the general budget
  - Need for additional paraprofessional due to IEP
  - Request to have the principal included in a longevity stipend will be

- The new math curriculum approved by the state requires new material
- ESSER money is no longer available for the purchase of Chromebooks
- SNAP is now included in Health Supplies, increase in immunization tracking software
- Increase to the fuel line as has run over many years in a row
- 39.7% \$208,839 county retirement
- Additional staff opting for life insurance
- New retirees in the central office have increased the amount of Health Insurance Retirees
- Decreasing reliance on some grants, such as the American Rescue plan
- Focusing on grants covering salaries
- Grant-funded supplies to be better tracked

  - Does some counseling services at tier 2 level in 3 groups
  - Tier 3 (IEP) 7, (504) 9
  - o Behavioral and crisis response increases monthly as well
  - Leads classroom discussions around many topics and integrates SEL
  - o Works with teachers, outside service providers
  - Works with school refusal students
- Lynn Oski psychologist
- PFAS finished everything on January 6
  - The construction team (Ardent) does not want to replace the bladder, although it was part of the original bid and contract
  - The Could this be a legal issue?
    - Believes that is up to the towns
- Winter concert was amazing, with over 200 guests attending
- Class events preschool gingerbread hunt and 3rd-grade publishing party
- Owen Cody (summer custodial) took over while another person was on paternity leave

      - Department of Energy will fund about 75% of the roof replacement cost

  - Junior ROTC placed second in the recent Drill team competition

## H. January Items

- o FY2025-FY2029 Beacon Mobility/FM Kuzmeskus 5-Year Transportation Contract (July 1, 2023-June 30, 2029) Vote to Award
  - Procurement with many other school districts was under the same bid from the guidance of FRCOG
    - Opened in early December only Kuzmeskus applied
    - 4 SRS busses one tier only combined price \$346,752 (approx. 11% increase)
    - With mid-day emergency tier 2,310 (shared with Erving)
    - Maximum 5% yearly increase, minimum 2.5% (fuel, driver salary, etc.)
    - Transportation is handled by each separate town by special town meeting
  - Beth moves to accept the bid; Mandy seconds
    - Will the emergency tier be folded into the general contract if it is not used?
      - Will look into that
    - Will need the chairs from each town to sign due to the timing of the meeting and the bid timeline
  - Transportation Bid passes unanimously
