### **Trustee Special Exception Permit Application**

Please check which permit you are applying for \*IF you are applying for more than one permit, you must submit ONE (1) Application PER Requested Permit.

Permits for Outdoor Dining, Outdoor Tables, Chairs and/or Benches, Outdoor Music, Entertainment and Outdoor Sales and Displays are issued annually, and applications must be received by February 1<sup>st</sup> in order to ensure a permit is approved by the Board of Trustees and secured for the calendar year. Submission after February 1<sup>st</sup> cannot be guaranteed a permit.
