Authorizes Application for a NYS Environmental Facilities Corporation Water Infrastructure Improvement Act (WIIA) Grant

WHEREAS, the NYS Department of Health and Environmental Facilities Corporation (EFC) provides partial funding for sewer and water infrastructure through the Water Infrastructure Improvement Act (WIIA), and

WHEREAS, the Village intends to complete construction of the Phase I service area in the Village downtown business district; and

WHEREAS, the maximum cost of said project is anticipated to be approximately \$13,268,000; and

WHEREAS, the Village has received grant approval from the Town of Southampton Community Preservation Fund for \$1,130,000 toward consultant costs associated with planning, engineering, design and specifications; and

WHEREAS, the Village has received grant approval from NYS Department of Environmental Conservation Water Quality Improvement Program in the amount of \$5,000,000 toward construction costs; and

WHEREAS, the WIIA program provides grant funding in the amount of 25% of the "net eligible project cost," and $\,$

WHEREAS, the WIIA program defines "net eligible project cost" by subtracting awarded grant funds from the total estimated project cost figure, in this case approximately \$1,784,500; and

WHEREAS, the Village would benefit from funding available through this the WIIA program to provide up to 25% of the net eligible project costs for the planned infrastructure improvements; and

WHEREAS, the Village will finance non-grant supported costs via bond financing as indicated in resolution # 13 above, with such local matching funds totaling approximately \$5,353,500; now therefore be it

RESOLVED, that the Village is hereby authorized to submit a funding application for WIIA funding in support of the Phase I sewer system project, of approximately \$1,784,500; and it is further

RESOLVED that the Mayor or her designee is hereby authorized to sign any required funding agreements with EFC and any associated documents required for the grant application.

Seconded by Trustee Frano and unanimously approved 3 Ayes, 0 Nays

PUBLIC COMMENT

Victor Conseco from Sandpebble gave a presentation on the Main Street project, explaining what is currently going on with the SCWA, replacing the water lines. There was a slide presentation.
