WHEREAS, the Board of Trustees adopted Chapter 174 of the Code of the Village of Westhampton Beach ("Underground Utility Lines") on September 6, 2018 after public hearing, and adopted amendments thereto on July 1, 2019, also after public hearing; and

WHEREAS, pursuant to Section 174-5A of the Code, all utility lines within the Downtown Main Street Corridor of the Village were directed to be installed underground or relocated to the rear of the properties located in the corridor; and

WHEREAS, pursuant to direction from the Village, the Long Island Power Authority ("LIPA") and PSEG Long Island relocated the electric utility lines in the Downtown Main Street Corridor to the rear of the properties within the corridor or underground; and

WHEREAS, the relocation and undergrounding of utility lines at the direction of a municipality such as the Village is governed by a tariff for LIPA duly adopted by the State of New York, which tariff provides for LIPA to recover the costs through a levelized surcharge applied to the kWh usage on the bills of ratepayers in the taxing jurisdiction over a twenty (20) year period; and

WHEREAS, Section 174-5H of the Code authorizes collection of the costs in this manner; and

WHEREAS, as required by the aforesaid tariff, the Village has agreed to enter into a Memorandum of Understanding with LIPA in form annexed.
