## LL # 1 of 2022 - Adding Chapter 131 "Smoking Prohibitions"

Motion made by Deputy Mayor Urban to open the public hearing, seconded by Trustee Frano and unanimously approved 3 Ayes, 0 Nays. Mayor Moore asked Village Attorney Steve Angel to explain this law, he explained this was to prohibit smoking around Village owned properties. Mayor Moore commented she felt it was the appropriate thing to do with Cannabis was legalized. The mayor asked if anyone would like to be heard, there being no response the mayor asked for a motion to close the public hearing, motion made by Trustee Frano seconded by Deputy Mayor Urban and unanimously approved 3 Ayes, 0 Nays.

WHEREAS, this Board has advertised a local law enacting the addition of Chapter 131 (Prohibition on Smoking in Public Places) to the Village Code; and

WHEREAS, pursuant to New York Public Health Law (Article 13-E), the State of New York granted the authority to local municipalities, including Villages, to prohibit smoking in certain outdoor areas.

WHEREAS, in 2021, as part of the legalization of cannabis, New York State recognized the negative impacts that marijuana smoke can have to individuals by expanding Article 13-E of New York State Public Health Law (Clean Indoor Air Act) to include cannabis.

WHEREAS, a public hearing was held on January 6, 2022; and

WHEREAS, all persons present at the meeting have had an opportunity to speak on behalf of or in opposition to the proposed Local Law, or any part thereof; and

WHEREAS, after due deliberation the Board of Trustees of the Village of Westhampton Beach deem it in the public interest to prohibit smoking in certain outdoor areas within the Village of Westhampton Beach, now therefore, be it

RESOLVED, that that the Board of Trustees of the Village of Westhampton Beach hereby enacts and adopts Local Law # 1 of 2022, a local law enacting the addition of Chapter 131 (Prohibition on Smoking in Public Places) to the Village Code to prohibit smoking in certain outdoor areas within the Village of Westhampton Beach; and that the Board of Trustees of the Village of Westhampton Beach authorizes the Mayor to sign the local law annexed; and that the Board of Trustees of the Village of Westhampton Beach hereby authorizes the Village Clerk to certify the local law annexed as a true and correct enactment adopted by this Board and to forward it in proper form to the Secretary of State for filing; and be it further

RESOLVED, this Local Law shall be effective immediately upon filing with the Secretary of State of the State of New York.

RESOLVED, that such unpaid taxes shall be collected by the sale for taxes as provided in Title 3 of Article 14 of the Real Property Tax Law of the State of New York, as it was in effect on December 31, 1994 pursuant to Article IV of Chapter 161 (Taxation) of the Code of the Village of Westhampton Beach, Chapter 602 of the Laws of 1993, Chapter 154 of the Laws of 2012 and Chapter 512 of the Laws of 2015, and

RESOLVED, that a copy of this resolution, duly certified by the Clerk, shall be transmitted forthwith to the Treasurer of this Village with the account, affidavit and certificate of such unpaid taxes, and that the Village Treasurer, upon receiving such an account of unpaid taxes and a certified copy of this resolution is authorized and directed to cause to be published in the official newspaper of the Village once each week for three successive weeks a list of statement of the real estate upon which such taxes are unpaid, as shown in the tax list, with the amount of the tax, a twenty-five dollar (\$25) advertising fee, interest and charges thereon and also a notice that the tax lien for such unpaid taxes will, on a day subsequent to the expiration of said three weeks, to be determined by said Village Treasurer and specified in said notice, be sold at public

auction at a place in said Village to be designated by said Village Treasurer, to discharge, the tax, twenty-five dollar (\$25) advertising fee, interest and charges aforesaid, which may be due thereon at the time of such sale, and that said Village Treasurer, at the time and place specified in said notice, proceed with the sale of the tax lien for such unpaid taxes, as above set forth, and continue at the same from day to day until the sale is completed.

RESOLVED, that in all cases where no bid shall be made on a Tax lien so offered for sale for amount sufficient to pay the said tax, fees, interest and charges, the said tax lien shall be deemed to have been sold to and purchased by the said Village of Westhampton Beach, New York.

BE IT FURTHER RESOLVED, that all remaining unpaid taxes for the year 2021-2022 shall be collected by Public Sale to be held on Tuesday, March 15 2022, at 10:30 a.m. in the Office of the Village Clerk-Treasurer and such unpaid taxes be advertised in the Southampton Press issues dated February 24, 2022, March 3, 2022 and March 10, 2022, in accordance with the statutory law.
