Acceptance of Governor John Adams Dix Windmill

WHEREAS, the Village of Westhampton Beach (the "Village") in association with the Westhampton Beach Historical Society was offered as a donation a historic windmill structure, identified as the "Governor John Adams Dix Windmill" by its owners Adam and Didi Hutt (the Hutts); and

WHEREAS, the Village Board seeks to accept the Governor John Dix Adams Windmill (the "windmill") upon relocation of the windmill to a municipal property owned by the Town and Village, which is located at 35 Main Street, Westhampton Beach, New York 11978 (a/k/a the "Great Lawn") and more particularly described on the Suffolk County Tax Map as SCTM# 905-11-1-1; and

WHEREAS, the Village and the Town acquired title to the Great Lawn by deed from St. Marks Church dated August 16, 2002 and filed in the Office of the Suffolk County Clerk on August 28, 2002 in Liber D00012206, page 160 (the "Deed"); and

WHEREAS, the Town of Southampton purchased the subject premises on behalf of the Village in 2002 pursuant to the Community Preservation Fund program. The Town designated the subject premises in the Village/Hamlet Green/ Parks and Recreation Target Preservation Area of the Community Preservation Project Plan as sites for park and recreation purposes; and

WHEREAS, St. Marks Church, the Town of Southampton and the Village of Westhampton Beach formally agreed that locating the windmill on the Great Lawn is in conformance with the public purpose of the acquisition by entering into a consent agreement authorizing the placement and restoration of the windmill on the Great Lawn; and

WHEREAS, the windmill has been relocated to the Great Lawn and Village now seeks

to authorize the acceptance of the windmill; and be it now, therefore

RESOLVED, the Village of Westhampton Beach hereby accepts the donation of the Governor John Dix Adams Windmill from the Hutts; and be it further

RESOLVED, that the mayor is hereby authorized to sign any necessary documentation required to effectuate the donation.
