Mayor Moore explained this was a discussion based on changes made in 1988 and now with the Sewer District coming to the Village it was agreed amongst the Board to make changes to multifamily residences. Building Department Administrator Brad Hammond explained the proposed changes, Mayor Moore asked if anyone had questions or comments; there being no responses the Mayor asked for a motion to close the public hearing, motion made by Trustee Frano, seconded by Trustee Rubio and unanimously approved 3 Ayes, 0 Nays, Trustee Tymann abstained from the vote.

Motion made by Deputy Mayor Urban:

WHEREAS, the Board of Trustees, as the legislative body of the Village of Westhampton Beach, is empowered to enact local laws pursuant to the provisions of Article 9 of the New York State Constitution, the Village Law, and the Municipal Home Rule Law; and

WHEREAS, a proposed Local Law has been prepared to amend Chapter 197-80.3 of the Village Code entitled "Multiple Dwellings; Family Residential" and

WHEREAS, the proposed Local Law, in final form, has been on the desks or tables of all the members of the Board of Trustees for seven calendar days, exclusive of Sunday; and

WHEREAS, the proposed local law is a Type II action under the State Environmental Quality Review Act, 6 NYCRR § 617.5(c)(26) & (33), because it is the adoption of local legislation in connection with routine or continuing agency administration and management; and

WHEREAS, due notice has been heretofore given of a public hearing to be held on the July 2, 2020, concerning the adoption of the proposed Local Law, which Local Law was available for viewing by the public during regular business hours in the Office of the Village Clerk; and

WHEREAS, the Board of Trustees has carefully considered the proposed Local Law during the seven-day period, conducted a public hearing on July 2, 2020, with respect to the Local Law, and has afforded all interested persons an opportunity to be heard at the public hearing; and

WHEREAS, this Board deems it in the public interest to adopt the proposed Local Law, to be effective immediately upon filing with the Secretary of State of the State of New York (the "Secretary of State").

NOW, THEREFORE, be it RESOLVED that that the Board of Trustees of the Village of Westhampton Beach hereby enacts and adopts Local Law # 9 of 2020, a local law amending Chapter 197-80.3 of the Village Code and that the Board of Trustees of the Village of Westhampton Beach authorizes the Mayor to sign the local law annexed; and that the Board of Trustees of the Village of Westhampton Beach hereby authorizes the Village Clerk to certify the local law annexed as a true and correct enactment adopted by this Board and to forward it in proper form to the Secretary of State for filing

Seconded by Trustee Frano and unanimously approved 3 Ayes, 0 Nays Trustee Tymann abstained from vote.
