1. FRONT GATES WILL NORMALLY BE OPEN.
RESTROOMS WILL NORMALLY BE OPEN BY 9AM AND
CLOSED AT 6PM UNLESS OTHER ARRANGEMENTS
ARE REQUESTED AT TIME OF RENTAL.
2. SHELTER WILL BE MARKED THE MORNING OF YOUR
EVENT WITH NAME OF RENTER OR ORGANIZATION.
3. PARK VEHICLES CLOSEST TO THE SHELTER. PARKING
ON THE GRASS IS NOT PERMITTED DURING WET OR
MUDDY CONDITIONS.
4. PICNIC TABLES MAY BE MOVED BUT MUST BE
PLACED BACK IN THEIR PROPER PLACES IN THE
SHELTER BEFORE LEAVING AND CANNOT BE LEFT
ON GRASS.

5. DECORATIVE ITEMS CAN BE TAPED OR ATTACHED TO THE SHELTER USING EXISTING NAILS OR DUCK TAPE. USING ADDITIONAL NAILS OR STAPLES ON TABLES IS STRICTLY PROHIBITED. ALL DECORATIONS MUST BE REMOVED BEFORE LEAVING.
6. ALL GARBAGE MUST BE PUT IN BAGS IN GARBAGE CANS AND SECURED SO THEY CAN BE PROPERLY DISPOSED OF BY THE TOWNSHIP.
7. DO NOT OVERLOAD ELECTRIC CIRCUITS.
8. DO NOT DAMAGE OR DESTROY RESTROOMS.
9. BALLFIELDS, VOLLEYBALL AND HORSESHOE PITS ARE AVAILABLE, FIRST COME, FIRST SERVE. YOU MUST BRING YOUR OWN SPORTS EQUIPMENT.
10. CHARCOAL GRILLS ARE AVAILABLE AT EACH SHELTER. FIREPIT RING IS ONLY AVAILABLE AT SHELTER 1. THERE IS SOME FIREWOOD ON SITE AVAILABLE FOR YOUR USE. ALL EMBERS AND FIRES MUST BE EXTINGUISHED BEFORE LEAVING.
11. IF YOU HAVE ANY ISSUES WITH THE ELECTRIC, WATER, THE MAIN GATE, RESTROOMS OR ANY OF THE FACILITIES WHILE USING THE PARK PLEASE CALL COUNTY CONTROL AT 814-724-2458 AND HAVE THEM CONTACT JOHN SHARTLE.
