Crawford County, Pennsylvania Ordinance No. 2000 - 1

AN ORDINANCE TO REGULATE STOPS AT ROAD INTERSECTIONS

Whereas, the Board of Supervisors of West Mead Township has determined that vehicle traffic should be required to stop at certain road intersections in West Mead Township, and that certain road intersections should officially be designated as stop intersections and should be controlled with stop signs, to protect the health, safety and welfare of the Township residents, motorists and the public; and

Whereas, the Township has performed the necessary traffic studies which support establishing stop intersections at the intersections hereby designated, and the Township has the authority to enact these regulations under the Pennsylvania Vehicle Code, 75 Pa.C.S. §§6109 and 6124;

Now, Therefore, be it ordained and enacted by the Board of Supervisors of West Mead Township, Crawford County, Pennsylvania, and it is hereby ordained and enacted by and with the authority of same as follows:

Section 1. Stop Intersections Established.

The roadway intersections in West Mead Township designated in Schedule A attached hereto are hereby established as stop intersections, and official stop signs shall be erected in accordance with applicable regulations in such a position that the stop sign faces traffic approaching the roadway designated "intersecting or through roadway" on Schedule A from the roadway designated "stop roadway" on Schedule A in the direction or directions indicated in Schedule A.

Section 2. Stop Required at Designated Stop Intersections.

Except when directed to proceed by a police officer or appropriately attired persons authorized to direct, control or regulate traffic, every driver of a vehicle approaching a stop sign shall stop at a clearly marked stop line or, if no stop line is present, before entering a crosswalk on the near side of the intersection or, if no crosswalk is present, then at the point nearest the intersecting roadway where the driver has a clear view of approaching traffic on the intersecting roadway before entering. If, after stopping at a crosswalk or clearly marked stop line, a driver does not have a clear view of approaching traffic, the driver shall, after yielding the right-of-way to any pedestrian in the crosswalk, slowly pull forward from the stopped position to a point where the driver has a clear view of approaching traffic. The driver shall yield the right-of-way to any vehicle in the intersection or approaching on another roadway so closely as to constitute a hazard during the time when the driver is moving across or within the intersection or junction of roadways and enter the intersection when it is safe to do so.

Section 3. Definitions.

As used in this Ordinance, the words "intersection", "roadway", and "stop" and other words shall have the meanings set forth in the Pennsylvania Vehicle Code, 75 Pa.C.S. § 102, as same may be amended from time to time, as applicable.

Section 4. Penalty.

Pursuant to Section 6502 of the Pennsylvania Vehicle Code, 75 Pa.C.S. §6502, any person who violates any provision of this Ordinance shall be guilty of a summary offense, and upon conviction, shall be sentenced to pay a fine of \$25.00 and costs of prosecution, and upon default of payment, may be sentenced to imprisonment for a period not to exceed 10 days. Each separate violation of this Ordinance shall constitute a separate offense.

Section 5. Enforcement.

Pursuant to Section 6301 of the Pennsylvania Vehicle Code, 75 Pa.C.S. §6301, *et. seq.*, enforcement shall be by action brought before a District Justice in the manner provided for the enforcement of summary offenses under the applicable sections of the Pennsylvania Vehicle Code and of the Pennsylvania Rules of Criminal Procedure.

Section 6. Incorporation of Amendments.

Amendments to the Pennsylvania Vehicle Code, Act 81 of June 17, 1976, P.L. 162, 75 Pa.C.S. §101, *et seq.*, as may be enacted by the Pennsylvania legislature and which relate to and modify any provisions of this Ordinance, shall be deemed incorporated into this Ordinance by reference on the effective date of said Legislative Act without further official action of the Township so as to preserve the intent and proper enforcement of this Ordinance.


Section 7. Repealer.

Section 8. Effective Date.

This Ordinance shall become effective Five (5) days after enactment.
