- 2. Application for a Small Flow Sewage Treatment Facility for Todd and Christina Giliberto on 21236 Phelps Road was reviewed and approved at the last meeting but it needs reconsidered due to the public comment time frame had not been completed until August 23, 2020.
  - A. The Application must be reviewed by the Township before submitting to DEP. This Small Flow Facility will replace her current system.
  - B. The Township is required to adopt a Resolution to revise the Township's Official Sewage Facilities Plan to include this Small Flow Facility. Also required is a Maintenance Agreement.
  - C. Motion to adopt Resolution No. 2020 8, revising the Official Sewage Facilities Plan and to authorize signing of the Agreement.

NOTE: As required under Act 205 of 1984, as amended, the Minimum Municipal Obligation for the Non-Uniformed Pension Plan for the year 2021 is estimated to be \$48,572.00, as certified by the Pension Plan Administrative Officer.

NOTE: The 2020 Census began April 1, 2020 and will continue into fall.
