 - D. **Motion to adopt Resolution 2022 - 10, establishing an Agricultural Security Area within West Mead Township consisting of property owned by Calvin Ernst, Jeff Peters, Martha Riddle, Robert Mona and Jerome Troyer.**

6. **Motion to adopt Resolution No. 2022 – 11, authorizing various Supplemental Appropriations for the 2022 Budget, specifically for the purchase of a police vehicle, road and fire equipment and to offset lost revenue due to the CoronaVirus COVID-19 Pandemic under the American Rescue Plan Act, in the amount of \$223,423.03. This Resolution amends Resolution No. 2022 – 3, as there were additional costs incurred in the purchase of the police vehicle and funds set aside to be used toward the purchase of a new HVAC unit for the Police Department.**

7. **Motion to adopt Resolution 2022 - 12, authorizing provisions of Act 57 of 2022 as adopted by the Pennsylvania General Assembly which amends the PA Local Tax Collection Law to require tax payer relief in certain situations from the Elected or Appointed Tax Collector for Real Estate Taxes.**
