# **ORDINANCES AND RESOLUTIONS**

## Resolution CM-22-18

RESOLUTION DECLARING THE INTENTION TO PROCEED UNDER THE ALTERNATIVE TAX DOCUMENT FORMAT PROVIDED UNDER SECTION 5705.281 OF THE OHIO REVISED CODE. Manager Sheridan stated that this was a formality in the way the Village funds itself. Scott Hurst made a motion, seconded by Greg Tracy, to adopt Resolution CM-22-18. After a roll call vote, the motion passed unanimously. Abstain: None.

# Resolution CM-22-20

RESOLUTION TO ELECT THE STANDARD ALLOWANCE AVAILABLE UNDER THE REVENUE LOSS PROVISION OF THE CORONAVIRUS LOCAL FISCAL RECOVERY FUND ESTABLISHED UNDER THE AMERICAN RESCUE PLAN ACT. Manager Sheridan said this was being done to use the simpler way of accounting for the ARPA funds received by the Village. #### Resolution CM-22-21
