ORDINANCES AND RESOLUTIONS

Ordiance CM-22-19

Ordinance CM-22-19 was introduced by council and read by Law Director Brosh. AN ORDINANCE AMENDING SECTION 91.11 POSSESSION, SALE AND USE OF FIREWORKS OF THE WEST MILTON CODE OF ORDINANCES FOR THE PURPOSE OF ADDRESSING THE PROVISIONS OF AMENDED SUBSTITUTE HB 172 CONCERNING THE RIGHT OF MUNICIPALITIES TO RETAIN THE REGULATIONS AND PROHIBITIONS OF THE DISCHARGE, IGNITION AND EXPLODING OF FIREWORKS THAT EXISTED PRIOR TO THE ENACTMENT OF AMENDED SUBSTITUTE HB 172. There was discussion between the council members. This will be voted on after the second reading of the ordinance.

Resolution CM-22-25

Resolution CM-22-25 was introduced by council and read by Law Director Brosh. A RESOLUTION AUTHORIZING AND APPROVING THE SUBMISSION OF AN ALTERNATIVE TAX DOCUMENT FOR THE FISCAL YEAR 2023. Chris Horn made a motion, seconded by Greg Tracy, to adopt Resolution CM-22-25. After a roll call vote, the motion passed unanimously. Abstain: None. Absent: Scott Hurst

RESOLUTION AUTHORIZING THE MUNICIPAL MANAGER TO APPLY FOR, ACCEPT, AND ENTER INTO A COOPERATIVE AGREEMENT FOR A WATER TOWER IMPROVEMENTS PROJECT BETWEEN THE MUNICIPALITY OF WEST MILTON, OHIO AND THE OHIO WATER DEVELOPMENT AUTHORITY. Manager Sheridan stated that this was a 0% loan thanks to the work of Jill Grise and Ben Herron. A motion was made by Greg Tracy, seconded by Chris Horn, to adopt Resolution CM-22-26. After a roll call vote, the motion passed unanimously. Abstain: None. Absent: Scott Hurst

Ordinance CM-22-27

Ordinance CM-22-27 was introduced by council and read by Law Director Brosh. AN ORDINANCE TO AMEND THE "OFFICIAL ZONING MAP OF WEST MILTON" AS ADOPTED BY CHAPTER 150.006 OF THE WEST MILTON CODE OF ORDINANCES. Manager Sheridan said this was being done to rezone land that is zoned for farming. It is the first step in the development process if the village wants to use this land for anything other than farming. This will be voted on after the second reading of this ordinance.

Ordinance CM-22-28

Ordinance CM-22-28 was introduced by council and read by Law Director Brosh. AN ORDINANCE AMENDING SECTION 51.22(B) SEWER RATE SCHEDULE OF THE CODE OF ORDINANCES FOR THE MUNICIPALITY OF WEST MILTON, OHIO. Manager Sheridan had 3 different rate increases to consider for the sewer with the amounts that would come back to the village. There would also be an additional 2% increase each year automatically. Discussion between the council members about why the money was needed, It was requested that the 10% rate increase be used for the sewer with a starting date of September 1, 2022. This will be voted on after the second reading of this ordinance.

Ordinance CM-22-29

Ordinance CM-22-29 was introduced by council and read by Law Director Brosh. AN ORDINANCE TO AMEND CHAPTER 52 - WATER RULES AND REGULATIONS AND SPECIFICALLY AMEND SECTION 52.116 OF THE WEST MILTON MUNICIPAL CODE TITLED WATER RATES AND MUNICIPALITY. Manager Sheridan said that a 17'% increase at the end of 3 years would generate approximately \$375,000. There will be an additional 2% increase automatically each year. After discussion between the council members they asked for Manager Sheridan to put together a 20% increase example before voting on this ordinance. This will be voted on after the second reading of this ordinance.

MUNICIPAL MANAGER

Fourth of July Paradew

Manager Sheridan stated that they needed to know what cars would be in the parade so they could plan for the set up. It was decided that the council members would ride on a village truck with their name signs.

Southside Project Update

Mr. Kauffman was present to update on the southside project. He said that he was working on getting various businesses and retail to become a part of this project.
