MUNICIPAL MANAGER

Comprehensive Plan

Manager Sheridan stated that Callabo is to begin work on downtown master plan. They will present at the September workshop. He is very excited about this plan.

2022 Paving Projects

Manager Sheridan stated that the 2022 paving projects are now complete. One section included a partnership with the township which was successful. This project came in under budget thanks to Mr. Herron.

Wastewater Treatment Plant and system

Manager Sheridan stated that staff working with Wessler Engineering has drafted a 10 year plan for the wastewater collection system. We will keep updating at this plan each year.

<u>Insurance</u>

Manager Sheridan stated that he is working on changing the employee health insurance for the Village. He is moving us to a bigger pool which will reduce the Village premiums by approximately \$20,000 less for better coverage.

The health insurance carrier will remain Anthem. He would like to use the savings for staff raises.
