WORKSHOP MEETING

September 27, 2022

Mayor Anthony Miller called the meeting to order at 7:30 p.m.

Present were: Mayor Miller; Councilmembers: Scott Hurst, Chris Horn, Greg Tracy, Kasey Metz, Sarah Metz, Don Dohrman. *Also present:* Manager Sheridan and Law Director Brosh.

PRESENTATION OF LIFEWISE ACADEMY

A presentation was given by Tara Schwartz, a representative from LifeWise Academy. She explained that West Milton Schools would be starting this program on November 1, 2022, for children in grades K-5. It is a program that will take place during the school day and it is for all students if they and their parents wish for them to participate. It will take place off school property; it is privately funded and it is parent permitted. The program is gospel centered, character focused, local church driven, it is a plug and play curriculum, it is for the nation (currently in 5 states), and it is an excellent program.

PRESENTATION OF ISAIAH'S PLACE-CHILD ADVOCACY CENTER PROGRAM

There was a presentation given by Jennifer Knisley and Bob Lybarger regarding the new child advocacy center program. This a program where children who have been the victim of a crime can go to be interviewed with a child advocate and the police and children services can attend so that the child may only have to tell the story one time rather than 3 or 4. There will also be services available for the child and family to help heal after an incident. The center is asked West Milton for a \$1,000 donation per year for these services.

FOODTRUCK VENDORS

Sandy who is opening up a coffee/food truck presented on her truck. She said that she would like to use Village water and electric. She will pay \$100.00 per month for the first 6 months plus the amount of usage. She would like to be open 7 days a week. They may need to pull the trailer out some days to attend a festival. She will hopefully be able to open in a couple of weeks. Discussion took place on other vendors wanting to set up their food trucks and where these vendors might set up.

ORDINANCES

Ordinance CM-22-47 An Ordinance Amending Section 50.01 Application for Excavation Permit, Streets and Sidewalks of The West Milton Code of Ordinances was discussed. This would require the company who requests the sidewalk cut to pay the fee (bond). If it is fixed back correctly, the company would get the bond back. If it was not fixed correctly, this would allow for money for the Village to fix it back properly.

Ordinance CM-22-48 An Ordinance Amended Section 137.09 Pointing and Discharging Firearms and Other Weapons of The West Milton Codified Ordinances was discussed. Chief Wright explained that this needed to be done in order for a shooting range build for use by the Village officers to be allowed to shoot within the Village. He also said there was some contradictory language in the ordinance that was being corrected.

FIREWORKS ORDINANCE

The fireworks ordinance was discussed. It was decided to repeal the previous ordinance passed and use the Ohio law that was passed.

RANDALL HOUSE

Manager Sheridan stated that the Randall Homes minor modification Mylar maps needed to be signed by the Mayor and Clerk.

ORDINANCES

There was discussion on two additional ordinances. These were CM-22-37: An Ordinance Amending Section 50.15 Obstruction of Gutters Forbidden in the West Milton Codified Ordinances and CM-22-28 An Ordinance Amended Chapter 50 Streets and Sidewalks, Section 50.99(A) Penalty of The West Milton Codified Ordinances.

OLD BUSINESS

Consideration of purchase of parcel: This located at Water and Miami Streets. This would expand the access into the current park. Manager Sheridan is going to continue to explore this idea and see what the price would be for this parcel. He will bring back what he finds out to the council.

Grant for Pedestrian Improvements on 571. Manager Sheridan said that it will cost \$1.4 million to put sidewalks on one side of 571 at Stillwater Crossings. A grant could be obtained for \$1 million. He will bring a resolution to the council meeting.


NEW BUSINESS
