## AN ORDINANCE AMENDING SECTION 150.333 CERTIFICATE OF ZONING COMPLIANCE OF THE WEST MILTON CODE OF ORDINANCES

**WHEREAS,** the current zoning code is in the process of being reviewed and updated by Choice One Engineering and the Planning Board; and

**WHEREAS,** the Planning Board has made a recommendation to Council to revise Section 150.333(D) of the Code of Ordinances due to it being in the Municipality's best interest to update certain sections of the zoning code prior to adopting an entirely new zoning code in order to clarify zoning compliance.

**NOW, THEREFORE,** the Municipality of West Milton, Ohio hereby ordains as follows, that:

**SECTION I:** 

Section 150.333 Certificate of Zoning Compliance shall be amended to read that reads as follows:

§ 150.333 CERTIFICATE OF ZONING COMPLIANCE.

- (A) It shall be a violation of this code to use, or permit the use or occupancy of any building or premises, or both, or part thereof hereafter created, erected, changed, converted, or wholly or partly altered or enlarged in its use or structure, until a certificate of zoning compliance shall have been issued therefor by the Enforcing Officer, stating that the proposed use of the building or land conforms to the requirements of this code.
- (B) Each application for a certificate of zoning compliance shall be accompanied by a fee of \$20. This application fee shall not be refunded in any case. In addition, a development fee shall be charged as follows: 1.5% of the estimated construction costs of the building, structure, accessory building, accessory structure, etc., at issue, as certified by the applicant and conditionally approved by the Municipal Manager or his/her designee. The Municipal Manager or his/her designee reserves the right to require submission of written estimate(s) for the planned construction before conditionally approving the amount of the development fee; and may require an additional amount if it is subsequently learned that the initial construction cost estimate certified by the applicant was unreasonably low.
- (C) These provisions shall apply to all buildings **and structures (including accessory buildings and structures)** and land uses except the raising of crops and other agricultural uses.

**SECTION II:** 

Council hereby directs that the proceeds collected from the 1.5% development fee shall be deposited as follows:

- a) 25% into the Sewer Fund,
- b) 25% into the Water Fund,
- c) 25% into the Street Construction and Maintenance Fund, and
- d) 25% into the General Fund for planning.

# AN ORDINANCE AMENDING SECTION 151.998(D) FEES, CHARGES AND EXPENSES FOR SUBDIVISIONS OF THE WEST MILTON CODE OF ORDINANCES

**WHEREAS,** Section 151.998 of the West Milton Code of Ordinances outlines the fees, charges and expenses for subdivisions within the Municipality of West Milton; and

**WHEREAS,** Section 151. 998(D) relates to inspections performed by the Municipal Engineer; and

**WHEREAS,** the Planning Board has recommended to Council to revise Section 151.998(D) for clarification purposes and to reflect the Municipality's current practices, as well as it being in the Municipality's best interest.

**NOW, THEREFORE,** the Municipality of West Milton, Ohio hereby ordains as follows, that:

**SECTION I:** 

Section 151.998 Fees, Charges and Expenses shall be amended to read as follows:

§ 151.998 FEES, CHARGES AND EXPENSES.

For general municipal administration of required improvements, there shall be at the time of submitting an application for preliminary plat approval, applicant shall pay a development fee of 1.5% based on the estimated costs, as certified by the applicant, of the total required-improvements and construction costs as to be constructed and/or placed within the subdivision, which such fee is to be conditionally approved and certified by the Municipal Manager or the Municipal designated Engineer, to be collected at the time of issuance of the municipal building permit for the improvements. The Municipal Manager or designated Engineer reserves the right to require submission of written estimate(s) of and/or other information relating to the estimated cost(s) of the planned improvement(s) before conditionally approving the amount of the development fee. At the time of the filing of the application for approval of the final plat, applicant shall pay any additional development fee that may be owed due to changes in the improvements to be constructed and/or changes in the estimated cost(s) of the improvements to be constructed.

**SECTION II:** 

Council hereby directs that the proceeds collected from the 1.5% development fee shall be deposited as follows:

- a) 25% into the Sewer Fund,
- b) 25% into the Water Fund,
- 25% into the Street Construction and Maintenance Fund, and
- d) 25% into the General Fund for planning.

**SECTION III:** 

This Ordinance shall be effective on and after the earliest date permitted by law.
