AN ORDINANCE ESTABLISHING REFUSE COLLECTION FEES AND AMENDING SECTION 53.32 REGARDING GARBAGE, REFUSE AND RECYCLABLE OF THE CODE OF ORDINANCES FOR THE MUNICIPALITY OF WEST MILTON, OHIO

WHEREAS, the Municipality of West Milton, Ohio will now be responsible for residential and multi-family households for the collection of garbage and refuse within the Village of West Milton; and

WHEREAS, the Municipality of West Milton, Ohio has authority to directly bill for the collection of these services pursuant to section 53.21 of the West Milton Code of Ordinances; and

WHEREAS, it is necessary to set up garbage and refuse collection fees; and

WHEREAS, it is also necessary to add to the current language in Section 53.32, due to the Municipality of West Milton beginning its own trash and refuse collection program; and

WHEREAS, it is further necessary to amend Section 53.32 to reflect the Village's new billing procedures.

NOW, THEREFORE, Be it ordained by the Council for the Village of West Milton, Ohio as follows:

SECTION I: Language contained in Section 53.32 of the West Milton Code of Ordinances is hereby added to with the following language clarifying the billing practice of the Municipality:

MUNICIPALITY BILLING PROVISIONS: Added Section (G)

(G) The billing rate per residence or customer for regular trash removal will be as follows:

\$24.10 for standard volume collection per month per household

\$22.20 for low volume collection per month per household

\$2.50 for extra toter receptacle (large or small) per month per household





SECTION II: This Ordinance shall become effective from and after the earliest date permitted by law.



RESOLUTION TO AUTHORIZE THE EMPLOYMENT OF THE MUNICIPAL MANAGER AND TO AUTHORIZE THE ADOPTION OF THE EMPLOYMENT AGREEMENT FOR THE MUNICIPAL MANAGER ATTACHED HERETO.

WHEREAS, the Municipality of West Milton, Ohio is currently in need of a Municipal Manager, and

WHEREAS, a hiring committee was formed for the sole purpose of collecting, reviewing and interviewing potential candidates for the position of Municipal Manager for the Municipality of West Milton, Ohio, and

WHEREAS, the hiring committee has recommended that Council retain the services of D. Jeffrey Sheridan as the new Municipal Manager for the Municipality of West Milton, Ohio, and

WHEREAS, Council believes it is in the best interest of the Municipality of West Milton, Ohio to retain the services of D. Jeffrey Sheridan as the new Municipal Manager.

NOW THEREFORE, Be it resolved by the Council of the Municipality of West Milton, Ohio that:

SECTION I:

That Council wishes to retain the services provided by the D. Jeffrey Sheridan as Municipal Manager of West Milton, Ohio.

SECTION II:

That Council pursuant to the Charter wishes to enter into the Employment Agreement attached to this Resolution which shall be incorporated herewith, as Exhibit "A".

SECTION III:

That Council hereby establishes the Compensation and Benefits for the Municipal Manager as specifically set forth in the Employment Agreement, with the salary to be \$120,000.00 per year.

SECTION IV:


The Mayor and Vice Mayor for the Municipality of West Milton are hereby authorized to execute the Employment Agreement for the Municipal Manager attached hereto.


