### **ORDINANCES AND RESOLUTIONS**

# Ordnance CM-22-53

Ordinance CM-22-53 was introduced by council and read by title only by Law Director Brosh. AN ORDINANCE TO APPROPRIATE FUNDS NECESSARY FOR THE VARIOUS DEPARTMENTS AND OFFICES OF THE MUNICIPALITY OF WEST MILTON, OHIO FOR THE YEAR 2023. Manager Sheridan said this is the budget for the year 2023 which includes goals for the upcoming year as well as raises for the employees. A motion was made by Don Dohrman, seconded by Sarah Copp, to adopt Ordinance CM-22-53. After a roll call vote, the motion passed unanimously. Abstain: None. Absent: Chris Horn

### Ordinance CM-22-54

Ordinance CM-22-54 was introduced by council and read by title only by Law Director Brosh. AN ORDINANCE AMENDING CHAPTER 53 GARBAGE, REFUSE AND RECYCLABLES OF THE CODE OF ORDINANCES FOR THE MUNICIPALITY OF WEST MILTON, OHIO. Manager Sheridan stated this was the work completed by Mr. Herron to bring this ordinance up to date since the Village began picking up the trash. A motion was made by Don Dohrman, seconded by Greg Tracy, to adopt Ordinance CM-22-54. After a roll call vote, the motion passed unanimously. Abstain: None. Absent: Chris Horn.

### Ordinance CM-22-55

Ordinance CM-22-55. AN ORDINANCE AMENDING SECTION 137.09 POINTING AND DISCHARGING FIREARMS AND OTHER WEAPONS OF THE WEST MILTON CODIFIED ORDINANCES. A Motion was made by Scott Hurst and seconded by Greg Tracy to table this ordinance until a later time. After a voice vote that passed unanimously, the ordinance was tabled. **Abstain:** None. **Absent:** Chris Horn.

### Resolution CM-22-56

RESOLUTION TO AMEND CM-19-16 AND CM-20-08 A REVISED ORGANIZATIONAL STRUCTURE WITH JOB CLASSIFICATIONS BY TITLE, STAFF LEVELS, AND ASSIGNED PAY GRADES WITH RANGES. Manager Sheridan said this was being done to compare with the 2023 Budget to reflect the raises. A motion was made by Sarah Copp, seconded by Scott Hurst, to adopt Resolution CM-22-56. After a roll call vote, the motion passed unanimously. Abstain: None. Absent: Chris Horn.

### Ordinance CM-22-57

Ordinance CM-22-57 was introduced by council and read in full by Law Director Brosh. AN ORDINANCE AMENDING SECTION 150.333(C) CERTIFICATE OF ZONING COMPLIANCE OF THE WEST MILTON CODE OF ORDINANCES. Manager Sheridan stated this was the first step in the Downtown Master Plan to encourage business growth in this area. This will be voted on after the second reading of the ordinance.

### Ordinance CM-22-58

Ordinance CM-22-58 was introduced by council and read in full by Law Director Brosh. AN ORDINANCE TO AMEND THE 2022 APPROPRIATIONS AND DECLARING AN EMERGENCY. Manager Sheridan this was being done to make the year end modifications to the budget. Most of the spending was being reduced from what was budgeted. A motion was made by Don Dohrman, seconded by Scott Hurst, to adopt Ordinance CM-22-58. After a roll call vote, the motion passed unanimously. Abstain: None. Absent: Chris Horn.

### Resolution CM-22-60

RESOLUTION TO APPROVE EMERGENCY REPAIRS AT THE WASTEWATER TREATMENT PLANT. Ben Herron said that 2 of the 3 pumps are not working properly. The third pump is not working at 100% but will try and rebuild it after these first two are fixed. A motion was made by Don Dohrman, seconded by Sarah Copp, to adopt Resolution CM-22-60. After a roll call vote, the motion passed unanimously. Abstain: None. Absent: Chris Horn.

### **MUNICIPAL MANAGER**

Manager Sheridan stated that leaf season has officially ended.

He also stated that the new Village website was up and running. He thanked the staff for getting it up and running. Please forward any information that the council would like to see on the website to him and he will get that up on the website.

He also stated that we need to re-codify ordinances so that it is up to date and complete.

### **OLD BUSINESS**

### North Main Street Water Service

Manager Sheridan said that he has tried to contact the owner and he has not talked with him. He needs to have direction from the council on how they would like to proceed with this matter. Manager Sheridan told him the Village is not willing to pay contractors. Council discussed and said that they were willing to pay the smallest tap fee and that if he wanted larger he would need to pay the difference. A motion was made by Don Dohrman and seconded by Greg Tracy that due to a unique situation at 253 North Main Street, the standard tap fee would be waived which is for no larger than a 1 inch line. After a voice vote, the motion passed with a 5 to 1 vote. **Abstain:** None. **Absent:** Chris Horn.
