# **ORDINANCES AND RESOLUTIONS**

## Ordinance CM-23-17

Ordinance CM-23-17 was introduced by council and read by title only by Law Director Brosh. AN ORDINANCE DETERMINING THAT THE REAL PROPERTY OWNED BY THE VILLAGE OF WEST MILTON AND LOCATED AT 26-28 LOWRY DRIVE TO BE SURPLUS AND NOT NECESSARY OR NEEDED FOR ANY CURRENT MUNICIPAL PURPOSE AND AUTHORIZING THE MUNICIPAL MANAGER TO ENTER INTO AN AGREEMENT FOR THE RENTAL OF SAME. Manager Sheridan stated this was the property that was going to be rented by The Gleaning Place. They needed a place to rent and wanted to stay in the community of West Milton. Ms. Copp said that she was glad they were able to rent this property and stay in West Milton because people enjoy going there. ### Ordinace CM-23-21

Ordinance CM-23-21 was introduced by council and read in full by Law Director Brosh. AN ORDINANCE AMENDING SECTION 50.12 REGARDING WASTE FORBIDDEN ON STREETS AND SIDEWALKS CODE OF ORDINANCES FOR THE MUNICIPALITY OF WEST MILTON, OHIO. Manager Sheridan said this was being done to update and make clear what is prohibited This will be voted on after the second reading of the ordinance.

### Resolution CM-23-22

RESOLUTION AUTHORIZING THE MUNICIPAL MANAGER TO ENTER INTO A CONTRACT WITH WESSLER ENGINEERING, INC., FOR THE PURPOSE OF INSTALLING A SYSTEM THAT ALLOWS REMOTE MONITORING AND COMMUNICATION OF THE EQUIPMENT ASSOCIATED WITH THE MUNICIPALITY'S UTILITY SYSTEMS. Manager Sheridan stated this is what was discussed at the workshop. It is important to the infrastructure of the utility systems. They are going to waive the bidding process as discussed at the workshop. Mr. Herron discussed how the system would benefit the Village and save in the long run. He said they are hoping to have this installed and in place by the end of the year. A motion was made by Mr. Hurst and seconded by Mr. Dohrman to adopt *Resolution CM-23-22*. After a roll call vote, the motion passed unanimously. **Abstain:** None. **Absent:** None.

### **MUNICIPAL MANAGER**

Manager Sheridan stated that bids for the street paving were opened and there was only one. It came in higher than expected. They are going to reopen the bidding process and change the dates to see if they get more bid options.

He also stated that the groundbreaking for the Randall house will be on April 18, 2023, at 3:00 p.m. and encouraged everyone to attend.

#### **OLD BUSINESS**

Scott Hurst stated that although putting the cones out on the first 2 spots at Miami and Front Streets would it be possible to take another. He doesn't want to lose the downtown parking, but he is concerned about safety for the drivers of the community.

Thanks to whoever put the bench out on Miami street in the s curve past the bridge. It was very helpful to a couple who walks that way and needed to take a break.

### **NEW BUSINESS**

Ms. Copp stated there is a new business downtown called Hometown Bakes near Wertz Variety Store. She said it is a nice addition to the downtown area.

She also said that they will be having the Spring open houses beginning on April 20, 2023, from 10-4 in the downtown area.

Third Thursdays will be starting again on May 18, 2023, from 5-8 p.m. They have lots of vendors signed up. They will be closing down a section of Route 48 each month. If you are a vendor or know someone who is and would like to be involved please contact Lynne Buss at the Village Peddler to set this up.

# **COMMENTS FROM CITIZENS**

James Green from Wagner Road was wondering if people pumping out basements into the street would need to stop. Manager Sheridan said they are working on this and working with these individuals. He also asked about pools being pumped into the street on Wagner. It was thought that this may be rain water from on the top of the pools from the winter.
