WEST MILTON PATCH





The West Milton Police Patch over the years has changed from an orange and black to triangle shape of blue and white in the 1950's-1960's to a green and white sphere looking patch in the 1970's. Again, in the 1980's the patch changed again to a blue and yellow then blue and white generic looking style. When Chief Kempel came to West Milton in 2008 he once again changed the patch to the current above configuration. However, the patch was yellow writing where there is white currently with a yellow edge. When Chief Busse took over in 2014 he again changed the patch to a shiny gold stitching for the letters and edging. Once again in the coming year of 2024 we will change the patch stitching to match the color scheme of our marked cars. We will go with the above patch for the traditional black and white with the lively colors in the middle reflecting our downtown. The patch is unique to our agency, having been designed under Chief Kempel.



FUNCTION CHART FOR DIVISION
















CITIZEN'S POLICE ACADEMY

West Milton Citizen's Police Academy Class IV was held Monday nights September 18, 2023, through November 13, 2023. Sergeant Stevens served as the Academy Commander and enjoyed getting to know the citizens in the class. This is an annual class held to familiarize citizens with the operations of the West Milton Police Division. Each officer of the Division gets an opportunity to teach in the classroom and meet each of the citizens. Citizen participants enjoy a ride along with the officers and visit the local incarceration facility as well as the 9-1-1 Center. This class visited our firing range and were able to shoot all the weapons issued to the officers. Each year the common theme at the end of the class is "I wish this class was not over". Citizen Survey's

During 2023 the agency sent out 112 surveys to random contacts the officers had during their shift. A template is used to make this random. Approximately every 25th call for service handled during the month receives a survey asking how the contact person would rate the service they received from the agency and officer. The surveys go out to people cited, arrested, filed a criminal complaint, or received some other services from the agency. The surveys are mailed will a self-addressed stamped envelope included for the return.

During 2023 we received 17 of the survey's back. All surveys received back in 2023 were mostly positive comments and ratings. Below is a sample of the comments received on the surveys in 2023.

- Your police department continues to be excellent in your professionalism and conduct. Outstanding officers.
- I'm happy they showed up for a well check. They were very concerned and just wanted to make sure I went to the hospital. I have so much respect for all officers. The only thing I will say is if these guys would sit on Sanlor Avenue they would catch a ton of people speeding. Praying for officers always! God Bless and protect all of you!!
- The first officer to respond was okay. The two officers that showed up later completely disregarded what actually took place. Continually try to say I changed my story. When I absolutely did not, and the entire police report I saw after was WRONG!! And absolutely should be fixed.
- Not sure of the safety, I don't know if the man that completely stopped in front of me was ever contacted regarding his actions.
- Body cams would be something all officers should be supplied. I believe body cams would being a peace of mind to all involved.
- I was looking for a driveway to ACES and couldn't see it and needed help, so I drove to the officers and asked for help. Very helpful.
