Did you know that we have several Infrastructure Projects underway or in planning phase for the City?

- Water Intake Relocation & Improvement Project: We are wrapping up the design of this large scale project and will start the contruction phase later this year.
- Lift Stations Capacity Improvement: We are currently applying for funding opportunities to bein the neccessary steps involved to increase the capacity capabilities of our lift stations while our City continues to grow.

• Oaken Hills Pump Track: More information will be coming soon as we begin looking at our timeline and await notification of a grant from the Oregon Parks & Recreation Department.

Other projects we are working on include our Wastewater Master Plan Update and the bank erosion at Huddleston Pond / Hampton Park.

At the August City Council meeting the primary focus was to decide what local action to take and put before the voters regarding regulation for Measure 109. Measure 109, known as the Oregon Psilocybin Service Act, allows for the manufacture, delivery and administration of psilocybin at licensed facilities.
