# City Council

At the September City Council meeting our City Council approved the recruitment and staffing for a replacement Community Support and Code Enforcement Office. The City Council also appointed Jennifer Eckels and Jason Foose to the City of Willamina Planning Commission.

A Work Session will be held Tuesday, October 11 at 5:00 PM regarding TMDL.

TMDL (Total Maximum Daily Load) is the calculation of the maximum amount of a pollutant allowed to enter a waterbody so that the waterbody will meet and continue to meet water quality standards for that particular pollutant. The City of Willamina is required to develop and submit a TMDL Implementation plan for DEQ.
