SITTING FOR THE TRANSACTION OF BUSINESS**

**RESOLUTION NUMBER 21-22-012**

**A Resolution rescinding Resolution Number 21-22-009 and authorizing the City Manager to pursue funding for Public Works and Code Enforcement and Community Support vehicles and execute necessary documents for that funding/purchase.**

**WHEREAS**, the City of Willamina City Council on December 14, 2021 adopted Resolution 21-22-009 authorizing the City Manager to pursue funding for two Public Works vehicles; and

**WHEREAS**, since Resolution 21-22-009 was adopted it has become apparent that the Code Enforcement and Community Support vehicle is failing to the point that repairs will be more expensive than the value of the vehicle; and

**WHEREAS**, City of Willamina management has confirmed that the replacement of the Code Enforcement and Community Support vehicle is an eligible expense under the USDA Communities Facilities grant rules; and

**WHEREAS**, the City of Willamina has ageing and failing equipment, vehicles, and facilities; and,

**WHEREAS**, the City Council and City Management have taken an aggressive position on the repair/replacement of ageing and failing equipment, vehicles, and facilities; and,

**WHEREAS**, the USDA Communities Facilities program provides the opportunity for cities to apply for grant funding for the purchase of public works and community support vehicles; and,

**WHEREAS**, the City of Willamina City Council wishes to pursue the USDA funding opportunity and/or alternative funding opportunities for the replacement of failing/ageing public works and community support vehicles; and,

**WHEREAS**, the City of Willamina City Council wishes to authorize the City Manager to pursue USDA Communities Facilities or other funding for the purchase of two public works vehicles, specifically to be light duty two or four wheel drive pick-ups or

similar and a code enforcement and community support vehicle to be either a sport utility vehicle or a light duty pick-up; and,

**WHEREAS**, the City of Willamina City Council wishes to authorize the City Manager to execute any necessary documents for the funding/purchasing of those public works vehicles.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WILLAMINA THAT:**

Resolution Number 21-22-009 his hereby rescinded and supplanted by Resolution Number 21-22-012 and that the City Manager shall have the authority to pursue funding and execute any documents on behalf of the City of Willamina, relating to the funding and/or purchase of two public works vehicles, specifically to be light duty two or four wheel drive pick-ups or similar and a Code Enforcement and Community Support Vehicle to be either a sport utility vehicle or light duty pick-up.
