 - Project A bids are due at 2:00pm with opening of the bids immediately following.
 - Project B bids are due at 2:30pm with opening of the bids immediately following.

 - One (1) at Garden Spot Park which came down over the railroad tracks,
 - One (1) at the water intake location near the pump house that took out a power line requiring the use of a generator for two (2) days.
 - This tree was a very large Oak tree and will sell them to Monroe Oak.
