AN ORDINANCE AMENDING RESOLUTIN 96-97-8 WHICH SETS FEES FOR BUSINESS LICENSES FOR BUSINESSES DOING BUSINESS IN THE CITY OF WILLAMINA.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Fees charged shall be: .

- Each business owner/operator whose principal place of business 1. is within the City, conducting or maintaining any business, as defined by Ordinance 556 and amended by Ordinance 587, shall pay an annual fee of \$35.00.
- Each business owner/operator whose principal place of business 2. is outside the City, conducting or maintaining any business, as defined by Ordinance 556 and amended by Ordinance 587, shall pay an annual fee of \$70.00.
- Any peddler, seller, agent, representative or other person engaged 3. in peddling or selling goods and/or services on a door to door itinerant basis as determined by Ordinance shall pay a daily license fee in advance of \$35.00 per/representative.
- Peddlers and sellers of goods and/or services from any temporary 4. location shall pay a daily license fee in advance of \$35.00 per/day per/representative.
- Business licensing for specific events may be exempted annually 5. by the Council. Other individual exemptions may be considered on a case by case basis.

FEES FOR BUSINESS LICENSES FOR BUSINESSES DOING BUSINESS IN THE CITY OF WILLAMINA. (ORDINANCE 613)

Fees charged shall be:

- 1. Each business owner/operator whose principal place of business is within the City, conducting or maintaining any business, as defined by Ordinance 556 and amended by Ordinance 587, shall pay an annual fee of \$35.00.
- 2. Each business owner/operator whose principal place of business is outside the City, conducting or maintaining any business, as defined by Ordinance 556 and amended by Ordinance 587, shall pay an annual fee of \$70.00.
- 3. Any peddler, seller, agent, representative or other person engaged in peddling or selling goods and/or services on a door to door itinerant basis as determined by Ordinance shall pay a daily license fee in advance of \$35.00 per/representative.
- 4. Peddlers and sellers of goods and/or services from any temporary location shall pay a daily license fee in advance of \$35.00 per/day per/representative.
- 5. Business licensing for specific events may be exempted annually by the Council. Other individual exemptions may be considered on a case by case basis.

AMUSEMENT DEVICES:

Any and all machines, devices and/or apparatus played or operated by the public for the purpose of exercising the skill, amusement or entertainment of a individual, and which require the player to pay either through such device or to the owner or custodian thereof any money, check, token or other representative of value for the privilege of playing or operating the same, whether or not the player receives any money, check, token or other representative of value in connection therewith or as a result of playing or operating such device(s).

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Fees charged shall be:

- 1. Each business owner/operator, whose principal place of business is within the City, conducting or maintaining any business, as defined by Ordinance 556 and amended by Ordinance 587, shall pay an annual fee of \$35.00 plus an additional \$2.00 per employee in excess of 2 per year.
- 2. Each business owner/operator whose principal place of business is outside the City, conducting or maintaining any business, as defined by Ordinance 556 and amended by Ordinance 587, shall pay an annual fee of \$70.00 plus additional \$2.00 per employee in excess of 2 per year.
- 3. Any peddler, seller, agent, representative or other person engaged in peddling or selling goods and/or services on a door to door itinerant basis as determined by Ordinance shall pay a daily license fee in advance of \$35.00 per representative.
- 4. Peddlers and sellers of goods and/or services from any temporary location shall pay a daily license fee in advance of \$35.00 per day per representative.
- 5. Business liceasing for specific events may be exempted annually by the Council. Other individual exemptions may be considered on a case by case basis.
