Applicant hereby consents to inspections, searches, and seizures, without the issuance of a search warrant, of the Special Event Premises, Applicant's licensed premises, and Applicant's records regarding the purchase and sale of alcoholic beverages at retail as determined necessary by Williams County and any of its employees, officials, and agents, including law enforcement personnel. Applicant does hereby agree that such inspections, searches, and seizures, may be made during the Special Event, during Applicant's regular business hours for its licensed premises, or at other times as may be necessary, in the discretion of Williams County and any of its employees, officials, and agents, including law enforcement personnel.

Applicant acknowledges that Applicant has read the Williams County Licensing and Permitting Regulations for the Retail Sale of Alcoholic Beverages and Title 5 of the North Dakota Century Code and understands the nature and gravity of, and will comply with, the responsibilities, duties, obligations, and limitations placed upon Applicant by virtue of holding a Williams County license and selling alcoholic beverages to the public.

Applicant shall not sell or serve any alcoholic beverages at retail for the Special Event until this application has been approved and the permit issued as required by Williams County Licensing and Permitting Regulations for the Retail Sale of Alcoholic Beverages and Title 5 of the North Dakota Century Code.
