AUDIT FINDINGS

Narrative:

The audit of the Williams County Correctional Center (WCCC) was conducted on August 9 and 10, 2018. Candy Snyder, a certified auditor, and Mark Snyder, auditor assistant, conducted the audit. The audit team conducted a review of the files, a facility tour and on-site interviews. The interim audit report was submitted on September 24, 2018.

The audit began with an entrance briefing on Thursday, August 9, 2018 attended by the Sheriff, the Jail Administrator, the Staff Sergeant and the PREA Coordinator. The briefing was followed by an extensive tour of the facility. The audit team ended the first day with interviews of specialized and random staff and continued into the evening hours with the second shift interviews. On the second day of the audit the audit team reviewed personnel records to include background checks, finalized the interviews of specialized staff and conducted interviews with inmates. The audit concluded with an exit briefing attended by the Sheriff, the Jail Administrator, the Staff Sergeant and the PREA Coordinator.

The tour began with the housing areas, toured all recreation spaces, sick bay and the intake/booking area. In the booking area offenders are screened, classified, searched and provided clothing. Initial information is given regarding PREA and how to report any allegations of sexual harassment or sexual abuse.

Two full-time Registered Nurses (RN) provide health care services. The sick bay area is private, can provide for the medical care and emotional support as well as a private area for the victim to be interviewed prior to transportation to the hospital for a forensic examination.

There are eight housing units at WCCC. All units had posters designating how to report sexual assault or sexual harassment and a kiosk available to report via an electronic message. All units had adequate camera coverage and an intercom that allows inmates to speak directly to the control room operator if immediate assistance is needed. Jail staff check every housing unit on rounds at a minimum of once each hour. The audit team directly witnessed rounds being conducted consistently. The inmates that are in segregated housing away from other inmates were not there involuntarily for protection from sexual assault or harassment or for reporting sexual assault or harassment. Typically, the suspected perpetrator of a sexual assault would be removed to a confinement area. In some instances a victim may be placed in an alternate housing unit for their protection, but not segregation or isolation. However, a victim of a sexual assault could be placed in segregation if he/she requested it for protective custody. One inmate had requested administrative segregation from fear of physical assault. However, staff worked with the inmate and the inmate was moved to a populated housing unit. While in administrative segregation the inmate did not lose any privileges – continued to attend recreation, watch television, participate in commissary, etc. The staff continue to monitor to assure the inmate is safely housed.

During the tour, work areas were inspected to include the laundry and areas accessed by inmate trusty

workers. There are multiple cameras within work areas. Most storerooms where there are no cameras are off limits to inmates. For storerooms or mop closets that are accessed by inmate workers in which there are no cameras, staff are aware that they never enter these areas if an inmate is present. They do not put themselves in a one-on-one situation off camera with an inmate. Cameras cover the entrances to these rooms.

The Control Room is operated continuously by a staff member who operates the door control via a touch screen control panel, the camera monitors and the intercom system. There is very comprehensive camera coverage in all the housing units, hallways and shared use areas. The WCCC has completed a blind spot assessment and have determined they will add three additional cameras to cover these areas. The cameras have 60 days of video storage.

Inmates are out of their housing unit if they are a part of the trusty work crew cleaning the facility or working in laundry; meal times, recreation time and attorney visits. Religious services and video visitation are done within the housing unit in the dayroom. Food Service is contracted with a local café who delivers the hot meal carts to the jail. A jail staff member takes the meal carts to the meal area. At no time does the contracted café worker come in contact with inmates. During meal times tables are set up in inmate recreation areas and each housing pod is moved to a recreation area for the three meals.

Contract and volunteer workers include a Turnkey commissary employee and religious service volunteers. Both types of employees have received documented PREA training from the PREA Coordinator and through the National Institute of Corrections PREA modules, although neither have extensive inmate interaction without jail staff present.

Sixteen (16) inmates were interviewed. The auditor randomly selected offenders interviewed from a list and selected inmates from each housing unit. The jail does not house youthful offenders. Specialty interviews were conducted for offenders who reported a sexual abuse incident, who reported previous sexual victimization during the risk screening, who identified as gay, lesbian, bisexual or transgendered during the risk screening and offenders in segregated housing.

There are a total of 64 staff at the jail. The command structure begins with the Sheriff who is the overall responsible authority of the jail. The Lieutenant is the Jail Administrator and is responsible for the day-to-day supervision of the jail. An Administrative Command Staff Sergeant assists the Lieutenant. The PREA Coordinator was appointed in March and his primary duty is to manage the facility's PREA compliance efforts. The auditor conducted specialized staff interviews to include the Sheriff, the Jail Administrator, the PREA Coordinator, the lead Investigator, the senior nurse, human resources, and the commissary contractor who is also a certified deputy.

Sergeants lead the shifts and Corporals and Deputy Jailers are responsible for supervision of the inmates. All line staff are trained to perform screenings for risk of victimization and abuse at intake and conduct the intake process. The auditor interviewed twelve (12) staff and included staff from both shifts. The auditor used random staff interview protocols as well as protocol questions for intake duties, screening duties, supervision of segregation, searches and first responders.

Staff did an excellent job in describing their prevention and detection efforts with regard to the PREA standards. Especially since their efforts toward meeting the standards only began within the last year with the newly appointed jail administrator. The PREA Coordinator and staff are to be commended for their training efforts that included various formats to include lecture with PowerPoint, handouts, multiple choice

tests, videos, and various National Institute of Corrections PREA related raining modules.

On August 10, 2018 the auditor conducted the exit meeting. The auditor provided preliminary information for each standard with the caveat that this was subject to change as the auditor continued to review documents, may have questions to be answered and prepares the interim report. Although the facility was compliant in many of the standards, the auditor expects there to be a corrective action period to ensure that newly enacted procedures and processes have the time needed to become fully institutionalized.

AUDIT FINDINGS

Facility Characteristics:

The WCCC is located in Williston, North Dakota. The jail is operated in a joint law enforcement center that includes the Williams County Sheriff's office, the Williston Police Department, law enforcement dispatch, the Bureau of Criminal Investigation, the North Dakota Highway Patrol and Williams County Court. The jail was remodeled in 2017 with significant changes to housing areas, changes to the layout for better supervision of inmates, the addition of cameras and longer retention times of video. The WCCC houses minimum and medium security inmates. The facility houses inmates from Williams County both sentenced and those awaiting court.

The first floor includes the booking/intake area, an unused dormitory style housing area that could be used for work release or overflow housing and laundry. The booking/intake area has a vehicle sally port, two search rooms, a property storage area, three booking desks, four group holding units and six cells with toilets/sinks, and an attorney visit area. There is an area used primarily by their 24/7 program that includes two (2) dry holding areas, three (3) wet cells and an equipment area used for intoximeter testing. Laundry includes the main wash/dry area, a chemical storage room and an inmate restroom. The second floor includes the entrances to two of the two-tiered housing areas, the sick bay suite, storage for commissary, the inmate trusty break area, the library, a multipurpose room, and three recreation areas of various sizes.

The third floor includes two control rooms, two interview rooms, administrative offices, and two staff restrooms. The main control room overlooks four housing pods A, B, C and D. The secondary control room overlooks five housing pods E, F, G, H and J (I is excluded because it is the designation for Intake on the first floor. The corridor that connects the two housing areas overlooks the large and small recreation areas. The medium-sized recreation can be observed from above, but is monitored during meal times and can be viewed from the control rooms via camera coverage.

Pod A consists of 12 upper and 12 lower cells with bunk beds and a toilet/sink in each cell, a dayroom, and private shower stalls. At the time of the audit this housing unit housed 24 male inmates.

Pod B consists of 4 upper and 4 lower cells with bunk beds and a toilet/sink in each cell, a dayroom, and private shower stalls. At the time of the audit this housing unit housed 3 male inmates on trusty status.

Pod C consists of 8 upper and 8 lower cells with bunk beds and a toilet/sink in each cell, a dayroom, and private shower stalls. At the time of the audit this housing unit housed 15 male inmates.

Pod D consists of 5 upper and 3 lower cells with bunk beds and a toilet/sink in each cell with the exception of D1 which is a single cell with a camera for special observation. Pod D has a dayroom and private shower stalls. At the time of the audit this housing unit housed 6 male inmates.

Pod E consists of 6 upper and 6 lower cells with bunk beds and a toilet/sink in each cell, a dayroom, and private shower stalls. At the time of the audit this housing unit housed 12 male inmates.

Pod F consists of 3 upper and 3 lower cells with bunk beds and a toilet/sink in each cell, a dayroom, and private shower stalls. At the time of the audit this housing unit housed 8 male inmates.

Pod G consists of 4 upper and 4 lower cells with bunk beds and a toilet/sink in each cell, a dayroom, and private shower stalls. This unit is for inmates placed in administrative segregation. At the time of the audit

this housing unit did not house any inmates.

Pod H consists of 6 upper and 6 lower cells with bunk beds and a toilet/sink in each cell, a dayroom, and private shower stalls. At the time of the audit this housing unit housed 2 female inmates.

Pod J consists of 6 upper and 6 lower cells with bunk beds and a toilet/sink in each cell, a dayroom, and private shower stalls. At the time of the audit this housing unit housed 18 female inmates.

Sick Bay has three beds. One inmate was being housed in sick bay. Policy is that an officer is present if an inmate is housed in the infirmary.

AUDIT FINDINGS

The Jail Administrator and the PREA Coordinator for the Williams County Correctional Center has done an outstanding job in implementing the PREA standards. They have both assumed their positions within the last year and from their first day, have been committed to ensuring that their facility becomes fully PREA compliant. They have utilized multiple methods to deliver PREA related information to both staff and inmates and have done it consistently over the past year to ensure that the information is retained. Staff were familiar with how to perform their responsibilities in prevention, detecting and responding to incidents of sexual abuse and sexual harassment. The auditor provided the interim audit report to the WCCC on 09-24-18. There were five standards that required corrective action. The WCCC achieved compliance with these standards over their corrective action period and a final audit report was issued on March 22, 2019.

Standard 115.15 Limits to cross gender viewing and searches

CORRECTIVE ACTION: The auditor required modification to the windows on the doors of some cells so that inmates on the toilet within these cells cannot be viewed from the control room area above. From 10-30-18 to 01-25-19 the WCCC provided photographic evidence that each of the affected windows on the cell doors had been modified to prevent observation from above.

Standard 115.17 Hiring and promotion decisions

CORRECTIVE ACTION: The auditor required that WCCC provide the method in which they will ask the three required questions relating to sexual misconduct of perspective employees, volunteers and contractors and staff being considered for promotion. The auditor required the WCCC provide documentation of this new procedure If any new hires, promoted staff, volunteers or contractors begin employment during the corrective action period. The WCCC provided documented evidence that these questions are being asked on 1-30-19. It is recommended that this be a part of the annual staff evaluation process.

Standard 115.22 Policies to ensure referrals of allegations for investigations

CORRECTIVE ACTION: The auditor required that the WCCC clarify who is responsible for administrative investigations – WCCC staff or the Williams County Sheriff's office detectives. On 01-26-19 the WCCC provided a memo clarifying policy with regard to administrative investigations.

Standard 115.53 Inmate access to outside confidential support services.

CORRECTIVE ACTION: The auditor required that the WCCC attempt to enter into a Memorandum of Understanding (MOU) with the Family Crisis Shelter of North Dakota and provide a signed copy of this MOU to the auditor. On 12-10-18 the WCCC.

Standard 115.81 Medical and mental health screenings; history of sexual abuse.

CORRECTIVE ACTION: The auditor required that all screenings that identify an inmate has suffered from previous sexual abuse be reported to medical staff so they may meet with the inmate to discuss the need for follow-up medical or mental health services. Medical staff are required to have a method of obtaining informed consent for reporting information about prior sexual victimization that did not occur in an institutional setting. On 10-03-18 WCCC provided policy 708 Health Appraisals that complies with this standard. On 01-26-19 conversations with WCCC staff verified that they have been offering follow-up medical or mental health services if there is a screening that an inmate has suffered from previous sexual abuse. This follow-up is documented within the inmate's medical file. In addition, the informed consent forms were provided to the health care staff and informed consent was added to their Standard Operating Procedure (SOP).

	Auditor Discussion
	The WCCC written policy mandates zero tolerance toward all forms of sexual abuse and sexual harassment. The WCCC has created the PREA Coordinator position. This person's primary responsibility is to oversee the management of the agency's efforts in PREA Compliance efforts. The PREA Coordinator has sufficient time and authority to develop, implement, and oversee agency efforts to comply with the PREA standards and has done an exceptional job in managing the WCCC's PREA compliance efforts.

	The facility does not contract for the confinement of its inmates with other private agencies/entities.

115.13	Supervision and monitoring
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The WCCC has developed, documented, and made its best efforts to comply on a regular basis with a staffing plan that provides for adequate levels of staffing. The auditor reviewed policy, the staffing plan, organizational structure, verified the staffing levels through the schedule that was provided and verified through direct observation while on the facility tour. The auditor interviewed the Sheriff, the Jail Administrator and the PREA Coordinator. All three individuals are strongly committed to ensuring that this jail is in compliant with the standards and has adequate staffing levels to safely supervise inmates under their care and custody. The WCCC throughout has strong, consistent leadership and a positive culture. They use video monitoring, electronic door monitoring and an intercom system to protect inmates against sexual abuse.
	Higher-level supervisors conduct and document unannounced visits. These rounds are documented in their computerized Jail Activity Log. In addition to frequent staff meetings and discussions, the sheriff, jail administrator and PREA Coordinator complete an annual review to assess, determine, and document whether adjustments are needed to their staffing plan or to policy and procedure.

115.15 Limits to cross-gender viewing and searches

Auditor Overall Determination: Meets Standard

Auditor Discussion

WCCC does not conduct cross-gender strip searches or cross-gender visual body cavity searches except in exigent circumstances or when performed by medical practitioners. The WCCC trains line staff in the proper methods to conduct cross-gender pat-down searches, and searches of transgender and intersex inmates, in a professional and respectful manner, and in the least intrusive manner possible, consistent with security needs. The auditor verified this in both interviews and in review of the training files. In the event a cross gender search is needed, WCCC will document all cross-gender strip searches and cross- gender visual body cavity searches. There have been no cross-gender searches for this audit review period. All interviews with both inmates and staff confirmed the practice of male staff searching male inmates and female staff searching female inmates. The facility prohibits examination for the sole purpose of determining gender and staff are knowledgeable of correct search procedures for transgender or intersex inmates. During the interview most physically demonstrated the correct technique for this search.

WCCC has policies and procedures that enable inmates to shower, perform bodily functions, and change clothing without staff of the opposite gender viewing their breasts, buttocks, or genitalia, except in exigent circumstances or when such viewing is incidental to routine cell checks. However, due to the construction of the facility, with the control room overlooking the housing areas, it was possible to see the toilet of some cells by observers in the control room area above. Staff provided several suggested modifications to the glass pane on the doors to blur or obscure the view into these cells. Policies and procedures require staff of the opposite gender to announce their presence when entering an inmate housing unit. The auditor directly witnessed announcements throughout the audit and the practice was confirmed through both staff and inmate interviews. All camera views were adequately blocked to ensure that inmates have privacy to toilet and change their clothing.

The WCCC will not search or physically examine a transgender or intersex inmate for the sole purpose of determining the inmate's genital status. If the inmate's genital status is unknown, it is determined during conversations with the inmate, by reviewing medical records, or, if necessary, by learning that information as part of a broader medical examination conducted in private by a medical practitioner.

CORRECTIVE ACTION: The auditor required modification to the windows on the doors of some cells so that inmates on the toilet within these cells cannot be viewed from the control room area above. From 10-30-18 to 01-25-19 the WCCC provided photographic evidence that each of the affected windows on the cell doors had been modified to prevent observation from above.

115.16	Inmates with disabilities and inmates who are limited English proficient

	Auditor Discussion
	WCCC provides interpretive services for inmates with disabilities or who are limited English proficient. There were no inmates who needed these services present at the time of the audit. The WCCC handbook and posters are also in Spanish. The WCCC does not rely on inmate interpreters or inmate readers and staff were aware of this policy. The instructions for using the interpretive service are posted near the booking desk and in control room areas. There is a multi-language sign that inmates can point to during intake to identify which language they speak. They verbally provide information to inmates who may have intellectual disabilities, limited reading skills, or are blind or have low vision.

115.17 Hiring and promotion decisions

Auditor Overall Determination: Meets Standard

Auditor Discussion

The WCCC conducts criminal background checks on applicants before an offer of employment is made, for current employees when they are promoted and for contractors and volunteers before their services within the jail begin. The auditor reviewed a random sampling of files and found the necessary background checks were ran prior to employment/service. WCCC performs a records check at least every five years of current employees, volunteers and contractors who may have contact with inmates. Their processes were confirmed by a review of records. In addition, all Correctional Officers participate in 24/7 duty that requires them to use the North Dakota Criminal Justice Information System (CJIS). The North Dakota Attorney General's office requires that all CJIS operators have background checks ran every five years.

The WCCC did not ask the three required questions outlined in this standard of perspective employees, volunteers or contractors or when considering staff for promotion. These questions are have you ever: 1) engaged in sexual abuse in any criminal justice facility: 2) been convicted of engaging or attempting to engage in sexual activity in the community facilitated by force, overt or implied threats of force, or coercion, or if the victim did not consent or was unable to consent or refuse; or 3) been civilly or administratively adjudicated to have engaged in the activity described above. In addition, they do not have a method of documenting that staff understand they have a continuing duty to report any such misconduct after they have been employed.

CORRECTIVE ACTION: The auditor required that WCCC provide the method in which they will ask the three required questions relating to sexual misconduct of perspective employees, volunteers and contractors and staff being considered for promotion. The auditor required the WCCC provide documentation of this new procedure If any new hires, promoted staff, volunteers or contractors begin employment during the corrective action period. The WCCC provided documented evidence that these questions are being asked on 1-30-19. It is recommended that this be a part of the annual staff evaluation process.

115.18	Upgrades to facilities and technologies
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	WCCC actively employs and updates technology such as video monitoring systems, door access systems, or other monitoring technology. WCCC considers how such technology may enhance their ability to protect inmates from sexual abuse. When designing their 2017 expansion of their facilities they added more cameras for coverage of blind spots and situated their control room for direct viewing of the housing areas. They ensured they have enough DVRS so that every camera is recorded so that they can go back and verify that policy and procedures are being followed after a reported incident and help in the investigative process. They have identified a few areas within their annual staffing plan where additional cameras will be added in 2018.

115.21 Evidence protocol and forensic medical examinations

Auditor Overall Determination: Meets Standard

Auditor Discussion

WCCC utilizes the investigative staff from the Williams County Sheriff's office for both administrative and criminal investigations. The lieutenant who leads the investigative process ensures that they take a team approach to include the lead investigator, the advocate who is automatically contacted when an individual is taken to St. Alexius Hospital where a Sexual Assault Nurse Examiner (SANE) is on staff. Williams County has a Sexual Assault Response Team (SART) and this team is utilized for all assaults – including within the jail. The investigator has received the necessary training for the collection of evidence as identified further under standard 115.34 Investigator Training. Evidence is collected using the North Dakota Sexual Assault Evidence Collection Protocol 5th Edition , June 2014.

Victims of sexual abuse have access to forensic medical exams by a SANE through the St. Alexius Hospital in Williston. Victims are offered the support of an advocate through the Family Crisis Shelter of North Dakota in Williston. They have a very coordinated effort as they have been absorbed by the Sheriff's office into the community plan SART response and this is outlined within the jail's Standard Operating Procedure (SOP). The auditor confirmed in conversation with the Sheriff's office that the response to a sexual assault is identical to that of a sexual assault within the community. As requested by the victim, a victim advocate accompanies and supports the victim through the forensic medical examination process, investigatory interviews and provides emotional support, crisis intervention, information, and referrals.

115.22 Policies to ensure referrals of allegations for investigations Auditor Overall Determination: Meets Standard **Auditor Discussion** The facility refers all allegations for investigation. The WCCC investigations were completed by qualified investigators from the Williams County Sheriff's Office. The auditor interviewed the lead investigator and reviewed the investigative documents. They were very well laid out, easy to read and contained all the necessary elements of a thorough investigative report. Investigative steps are outlined in their PREA policy contained within their Standard Operating Procedures. However, there is a discrepancy between the policy and what was stated during interviews as to which agency conducts administrative investigations. The WCCC publishes its entire PREA Operating Procedures manual to include the section on its investigative policy on their website http://www.williamsnd.com/usrfiles/resources/WCCC_PREA_SOP.pdf CORRECTIVE ACTION: The auditor required that the WCCC clarify who is responsible for administrative investigations – WCCC staff or the Williams County Sheriff's office detectives. On 01-26-19 the WCCC provided a memo clarifying policy with regard to administrative

investigations.

Employee training
Auditor Overall Determination: Meets Standard
Auditor Discussion
PREA training with staff was apparent during the interviews as staff were very knowledgeable in the required competencies such as the correct first responder response – separate, provide care, protect evidence, call for assistance, notify shift supervisor and provide a written report. Staff were knowledgeable in how to recognize signs of sexual abuse and how to communicate effectively with LGBTI inmates. The PREA Coordinator leads the training efforts and uses a multi-throng approach to ensure that the information is retained. The staff are trained via training sessions by the PREA Coordinator on various standards such as a broad PREA training overview, cross-gender pat searches, the staffs' role responding to sexual abuse, how to respond effectively and professionally to LGBTI offenders, etc. In addition, staff participate in the National Institute of Corrections PREA training curriculum. Staff take small, mini quizzes on various topics as presented by the PREA Coordinator at random times. If staff need strengthened training, or the PREA Coordinator through his own research identifies new information that would be beneficial for all staff, he presents it to the Jail Administrator who approves and disseminates it to all staff. This method shows support of the Administration because the Administrator backs up the information that is pushed out by the PREA Coordinator. Training is outlined well. All staff have signed an acknowledgment form that they have received PREA training and understand the points outlined in the standard that they are responsible for. The PREA Coordinator maintains all training documentation to include NIC certificates, quizzes, acknowledgment forms, etc.

115.32	Volunteer and contractor training
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The facility provides PREA training to their religious volunteers and contractors. The auditor viewed and verified documentation of training that has been provided to volunteers and contractors. The auditor spoke with a religious volunteer and a contractor who were able to state the facility's zero-tolerance policy and the appropriate actions to take if an inmate indicated sexual abuse. The level and type of training provided to volunteers and contractors is based on the services they provide and level of contact they have with inmates, but all volunteers and contractors who have contact with inmates are notified of the zero-tolerance policy regarding sexual abuse and sexual harassment and informed how to report such incidents.

115.33	Inmate education
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The inmates receive training, a pamphlet and a handbook on the day of arrival that outlines important PREA information. There are posters throughout the facility. In addition, the PREA Coordinator provides more in-depth training to inmates through a video and the opportunity to ask questions. When an inmate initially signs on to the kiosk within their housing unit the screen displays PREA information regarding their rights to be free from sexual abuse and sexual harassment, to be free from retaliation for reporting such incidents and methods of reporting. The inmate must acknowledge reading it before having access to the kiosk.
	The interviews confirmed that inmates were well aware of how to report and were familiar with multiple ways to report. The training is documented through the inmates' signature on an acknowledgement form. The inmates stated they feel safe and that their staff are very professional. Many reported that if they needed to report anything they would report it directly to their staff.

115.34	Specialized training: Investigations
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	Most sexual assault investigations are conducted by the lead investigator. If not directly investigated by the lieutenant, the investigators are led and supervised by the lead detective who reviews the final report. The lieutenant has received specialized training in sexual assault investigations to include an Advanced Crime Investigation courses, the National Child Symposium on Sexual Assault, the PREA investigation courses through the National Institute of Corrections and a recent segment of training specifically on collecting forensic evidence. In addition to her training she has been in law enforcement for sixteen years, with the past thirteen years investigating as a detective. In some instances the Sheriff's office may call in the North Dakota Bureau of Investigation to conduct the investigation.

115.35	Specialized training: Medical and mental health care
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The nurses have completed both the basic training through NIC PREA: Your Role Responding to Sexual Abuse and the medical and mental health specialized training through NIC. During the interview the RN was very knowledgeable about the appropriate response for transporting the inmate to the hospital for sexual assault forensic exams and protecting evidence to aid in the prosecution of a sexual assault. The RN was previously certified as a SANE but let her certification expire in 2010. The WCCC does not provide in-house mental health services. Inmates are referred to a provider at the Northwest Human Services Center for mental health care.

115.41	Screening for risk of victimization and abusiveness
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The WCCC screening process is completed through a computerized booking system done upon intake. Intake screenings take place usually within a few hours of arrival, but never exceed 72 hours. Once the booking is complete, only limited staff have access to the PREA screening information. The PREA Coordinator reassesses all inmates within 30 days of arrival, when there is an incident, or upon request to ensure the inmate is safely housed based on all information.

115.42	Use of screening information
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	WCCC makes individualized determinations about how to ensure the safety of each inmate. In deciding whether to assign a transgender or intersex inmate to a housing unit for male or female inmates, and in making other housing and programming assignments, WCCC considers on a case-by-case basis whether a placement would ensure the inmate's health and safety, and whether the placement would present management or security problems. A transgender or intersex inmate's own views with respect to his or her own safety would be given serious consideration. All inmates shower separately shower separately from other inmates. WCCC does not place lesbian, gay, bisexual, transgender, or intersex inmates in dedicated units solely on the basis of such identification. An inmate's risk level is reassessed when warranted due to a referral, request, incident of sexual abuse, or receipt of additional information that bears on the inmate's risk of sexual victimization or abusiveness. Inmates are not disciplined for refusing to answer, or for not disclosing complete information in response to, questions asked. Once the questionnaire is complete, access to the information is limited only to staff within the WCCC that need the information in order to safely protect the inmates.

115.43	Protective Custody
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The WCCC considers the least upsetting placement for the alleged victim. Staff interviews confirmed that inmates at high risk for sexual victimization are not placed into protective custody unless the inmate cannot be protected by any other means. A review of status for protective custody is completed at a minimum of every 30 days. They have not placed any alleged inmate victims of sexual abuse or sexual harassment in involuntary segregated housing.

115.51	Inmate reporting
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	WCCC provides multiple internal avenues for inmates to report sexual abuse, sexual harassment and retaliation (i.e. telling any staff member, medical staff, through a grievance, submitting an inmate request through the kiosk, or writing to the PREA Coordinator. In addition, there are multiple external avenues that are provided to the inmate. They may write or call the numbers provided for external sexual abuse victim's organizations to include the Family Crisis Shelter of North Dakota via the National Sexual Assault Hotline. Inmates can report to their family or any other outside third party. Third Party reporting information is the Inmate interviews confirmed that inmates are aware of their options. The auditor verified with the Crisis Center that they will accept calls from inmates at WCCC for reporting purposes. The facility also provides the address to the North Dakota Department of Corrections and Rehabilitation Office of Facility Inspections.

115.52	Exhaustion of administrative remedies

	Auditor Discussion
	Inmates may file a grievance. However, all allegations of abuse/harassment when received by staff, would immediately result in an administrative or criminal investigation. There is no time limit on when an inmate may submit a grievance regarding an allegation of sexual abuse. Inmates are not required to use an informal grievance process or to otherwise attempt to resolve with staff an alleged incident of sexual abuse. A WCCC inmate may file an emergency grievance alleging an inmate is subject to a substantial risk of imminent sexual abuse. Staff will immediately forward such a grievance to the jail administrator for which immediate corrective action will be taken.

115.53	Inmate access to outside confidential support services
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The Williams County Sheriff's office has partnered with the Family Crisis Shelter of North Dakota to provide sexual abuse victims with emotional support services. Although there is no Memorandum of Understanding with this agency and the WCCC, the Sheriff's office did state they consider the WCCC under their SART program and that an individual within the jail has access to these services the same as any person within the community. The auditor spoke with a crisis counselor from a housing area within the jail. The counselor stated they would provide support services to an inmate just as they would anyone within the community.
	CORRECTIVE ACTION: The auditor required that the WCCC attempt to enter into a Memorandum of Understanding (MOU) with the Family Crisis Shelter of North Dakota and provide a signed copy of this MOU to the auditor. On 12-10-18 the WCCC provided the signed copy of the MOU with the Family Crisis Shelter of North Dakota.

115.54	Third-party reporting

	Auditor Discussion
	The WCCC website provides information on how an individual can make a third party report. Third parties are able to report sexual abuse and sexual harassment to any facility staff member. In addition there are posters in the visit area and on line at http://www.williamsnd.com/usrfiles/resources/PREA_Public_Poster.pdf. These posters give the number to the National Sexual Assault Hotline; the address for Just Detention International and the address, phone number and email of the WCCC PREA Coordinator. WCCC has not received any third party reports. Interviews with staff and inmates confirm that staff and inmates are aware that third party reporting options are available.

115.61	Staff and agency reporting duties

	Auditor Discussion
	The WCCC PREA policy contained within their Standard Operating Procedures requires all staff to immediately report any knowledge, suspicion, or information regarding an incident of sexual abuse or harassment and for staff not to reveal any information related to a sexual abuse report to anyone other than the extent necessary. Staff interviewed understood this procedure. Inmate interviews supported the fact that inmates are also aware of the reporting and confidentiality requirements of sexual abuse and sexual harassment. The medical staff did not initially have a practice of informing inmates of their limits of confidentiality. However, they recently posted a sign within the medical spaces notifying them that if inmates report that they were hurt or hurt others they must report that to jail administration.

	Through interviews with the Sheriff, the Jail Administrator and the PREA Coordinator upon receiving an allegation that an inmate was sexually abused while confined at another facility, they notify the head of the facility or appropriate office of the agency where the alleged abuse occurred. An investigation will be initiated immediately. This notification is to be made immediately and documented. There was one incident reported regarding sexual abuse that occurred at another facility and it was reported to the other agency.

115.63	Reporting to other confinement facilities

	Auditor Discussion
	Through interviews with the Sheriff, the Jail Administrator and the PREA Coordinator upon receiving an allegation that an inmate was sexually abused while confined at another facility, they notify the head of the facility or appropriate office of the agency where the alleged abuse occurred. An investigation will be initiated immediately. This notification is to be made immediately and documented. There was one incident reported regarding sexual abuse that occurred at another facility and it was reported to the other agency.

115.64	Staff first responder duties

	Auditor Discussion
	Staff provided appropriate responses during the interviews outlining the duties of first responders. They stated they would separate the victim and abuser, move the victim to medical for a more private setting, preserve evidence so that it can be collected by the investigator; do not allow inmates to take any actions that could destroy evidence, contact medical staff to provide immediate medical care and contact a supervisor.

115.65	Coordinated response

	Auditor Discussion
	The WCCC has a detailed comprehensive PREA Plan with a coordinated response. Also, one of the ways the plan is disseminated to staff is through an easy to read flow chart ensuring their coordinated response includes first responders, medical, mental health, investigators and supervisors.

115.66	Preservation of ability to protect inmates from contact with abusers
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	WCCC has a disciplinary process that allows for staff discipline if staff are involved in any type of sexual misconduct or for violating any agency sexual abuse or sexual harassment policies. Discipline can include reassignment of a post, administrative leave during an investigation, discipline for actions or failures to act that could lead to sexual misconduct by others. Discipline can include dismissal or termination from employment.

115.67	Agency protection against retaliation
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The WCCC PREA policy contained within their Standard Operating Procedures covers all elements of this standard. The PREA Coordinator is designated to monitor for retaliation up to a 90-day period or for as long as needed.

115.68	Post-allegation protective custody
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	WCCC demonstrated compliance with all elements of this standard. After interviewing the Jail Administrator, the PREA Coordinator, staff assigned to supervise segregated housing, and inmates, there were no instances of using segregation to protect an inmate who had alleged to have been sexually abused. Staff stated segregated housing would only be used at the request of the inmate. There are multiple housing options available to provide adequate separation for the protection of an inmate. The standard practice would be to place the suspected abuser in segregated housing.

115.71	Criminal and administrative agency investigations

	Auditor Discussion
	The auditor reviewed agency investigative files and conducted interviews with the lead investigator, staff and inmates. The facility had one unfounded incident of sexual harassment in 2017. To date in 2018 there has been one unfounded case of sexual assault and one substantiated case of sexual harassment. The incidents were properly investigated as outlined by their policy and PREA standards. Investigators have received specialized training to conduct sexual abuse investigations. Administrative investigations include efforts to determine whether staff actions/failures contributed to the abuse. The investigations are documented through written reports and include physical/testimonial evidence, credibility reasoning assessments and investigative facts and findings. All written reports will be retained for at least seven (7) years from inmate(s) discharge. Investigations will not be terminated due to the departure of an alleged abuser or victim. The facility will cooperate with outside investigators and will remain informed of the investigation progress.

115.72	Evidentiary standard for administrative investigations

	Auditor Discussion
	The WCCC policy stipulates no standard higher than a preponderance of evidence will be used in making a determination of alleged sexual abuse/harassment. Through interviews with the lead investigator they use no standard higher than the preponderance of evidence in making final determinations of sexual abuse/harassment.

115.73	Reporting to inmates
	Auditor Overall Determination: Meets Standard
	Auditor Discussion
	The WCCC policy requires inmates to be informed as to whether the allegation was substantiated, unsubstantiated or unfounded; whether the allegation involved staff, contractors, volunteers or another inmate. If a sexual misconduct allegation is confirmed, the inmate will be informed of the abuser's employment/volunteer/contractor status; and as appropriate of an indictment/conviction. Interviews with the Jail Administrator confirmed practices involving all standard components were in place. Information regarding the status of investigations is readily available and was provided to the auditor. The inmate is made aware of the outcome.

115.76	Disciplinary sanctions for staff

	The WCCC policy requires that staff members who have violated sexual abuse, sexual harassment or retaliation policies are subject to disciplinary sanctions. In reviewing investigative files and conducting interview with the Sheriff and the Jail Administration it was confirmed that agency policy is followed and appropriate disciplinary measures are used commensurate with the violation. All allegations are investigated by the Williams County Sheriff's office so when criminal acts are suspected law enforcement is automatically aware.

	The WCCC policy states contractors and volunteers are subject to disciplinary actions including termination for violation of sexual abuse policy.

115.78	Disciplinary sanctions for inmates

	For incidents of inmate-on-inmate sexual abuse, sexual harassment or retaliation, administrative sanctions will be handed out following the formal disciplinary processes and applied commensurate with the level of infraction. The WCCC prohibits all sexual activity among offenders and does not deem such activity to be sexual abuse if the activity is consensual. However, consensual activity is thoroughly investigated to ensure that it is truly consensual and not coerced. The WCCC follows policy and practice as was determined through interviews and reviews of investigative files.

115.81 | Medical and mental health screenings; history of sexual abuse

Auditor Overall Determination: Meets Standard

Auditor Discussion

PREA screenings are completed by intake staff to determine if an inmate has experienced prior sexual victimization or has previously perpetrated sexual abuse, whether it occurred in an institutional setting or in the community. This information is used for protective measures such as housing placement. However, the inmate is not offered a follow-up meeting with a medical or mental health practitioner within 14 days of the intake screening. All inmates are seen by medical within 14 days of intake, but the nurse does to have this information to determine if there is a need for follow medical or mental health services. Medical staff are aware of mandatory reporting laws for inmates.

Staff understand that any information related to sexual victimization or abusiveness is strictly limited to medical and mental health practitioners and other staff, as necessary, to inform treatment plans and security and management decisions, including housing, bed, work, education, and program assignments. Medical staff did not inform inmates the limitations of confidentiality at the initiation of services. However, the recently posted a notice in the medical spaces notifying inmates that they must report sexual abuse to jail administration. Medical staff do not outlined a practice of obtaining informed consent from inmates prior to reporting about prior sexual victimization that did not occur in an institutional setting. There have been no incidents reported to them that this practice would apply.

CORRECTIVE ACTION: The auditor required that all screenings that identify an inmate has suffered from previous sexual abuse be reported to medical staff so they may meet with the inmate to discuss the need for follow-up medical or mental health services. Medical staff are required to have a method of obtaining informed consent for reporting information about prior sexual victimization that did not occur in an institutional setting. On 10-03-18 WCCC provided policy 708 Health Appraisals that complies with this standard. On 01-26-19 conversations with WCCC staff verified that they have been offering follow-up medical or mental health services if there is a screening that an inmate has suffered from previous sexual abuse. This follow-up is documented within the inmate's medical file. In addition the informed consent forms were provided to the health care staff and informed consent was added to their Standard Operating Procedure (SOP).

Access to emergency medical and mental health services Auditor Overall Determination: Meets Standard Auditor Discussion A review of facility policy, documentation and interviews confirmed that PREA requirements are met for access to emergency medical and mental health services. In the event services after hours are not available by the facility medical staff, inmates are taken to CHI St. Alexius Health in Williston.

115.83	Ongoing medical and mental health care for sexual abuse victims and abusers

	Auditor Discussion
	The WCCC policy requires that medical and mental health evaluations and treatment are offered at no cost to sexual abuse victims and abusers. Medical staff verified this as a consistent practice. Tests for sexually transmitted infections and pregnancy are offered. Inmates are referred to a provider at the Northwest Human Services Center for mental health care.

115.86	Sexual abuse incident reviews

	The facility conducts formal sexual abuse incident reviews following each sexual abuse investigation specifically answering the questions posed within the standard. The review includes upper-level staff, supervisors, investigators, and medical staff. Compliance with this standard was met as supported through interviews.

	Auditor Discussion
	The facility collects uniform data for all allegations of sexual abuse based on incident reports and investigation files. Aggregate annual data is available and was provided to the auditor.

	The facility conducted an annual review of data and prepared an annual report. This review was attended by all upper level managers as well as the progress made through their previous year in addressing sexual abuse.
