DEMOLITION INSTRUCTIONS

REQUIRED ACTIONS:

- Call the Utility Billing office and notify them that work will begin at least 2 days prior to beginning demolition: 937-382-5711
- Debris from demolition cannot be hauled outside the City. Any discarded materials must be brought to the Wilmington City Landfill. Call 937-382-6474 for more information.
- Water and sewer service lines must be terminated and capped at the right-of-way. Service line termination must be inspected prior to covering. Call 937-302-6300 for inspection of water service. Call 937-302-6303 for inspection of sanitary line.
- Contact other utilities: Centerpoint Energy (gas), AES (electric), and cable/telephone to ensure these services are terminated prior to demolition.
