# **Wilmington City Council**

February 15<sup>th</sup>, 2024

Wilmington City Council met in regular session on Thursday, February 1<sup>st</sup>, 2024, at 7:00 p.m. at 69 N. South St. Wilmington, Ohio, with President Matt Purkey presiding.

## CALL TO ORDER

President of Council called the meeting to order at 7:00 p.m.

Dave Hinman and Hanna Lutz provided the following "Statement of Compassion":

We, as members of the body of Christ, in Wilmington, Ohio, hereby declare that it is our deepest conviction and belief that all people are created by God and born sacred and worthy of all basic human rights. These are food, water, air, shelter, and access to religious services. Our love for God is powerless if not for our love for others (I John 4:20). The deepest expression of love is giving, as modeled by God Himself (John 3:16). Therefore, we aspire to express a unified statement on behalf of all of our brothers and sisters that we as a community and Christian body will continue to serve and love all those we encounter, without question and irrespective of condition or circumstance.

This statement was also accompanied by 175 collected signatures of support.
