Dear Parents:

In the year of 2014, the State of South Carolina passed Act 293 known as "Erin's Law," as part of health and safety education for its public schools. The purpose of the law is to ensure all students, pre-kindergarten through high school, receive this prevention instruction during the academic school year. The intent of Erin's Law is to give students skills in knowing how to stay safe from sexual assault and how to report any incidents of sexual assault.

The South Carolina Department of Education created Erin's Law instructional units in support of the new legislation that amended the Comprehensive Health Education Act. South Carolina Code of Laws Section 59-32-20 (B) was amended to read that the State Board of Education through the South Carolina Department of Education "shall select or develop instructional units in sexual abuse and assault awareness and prevention, with separate units appropriate for each age level from four-year-old kindergarten through twelfth grade."

Parental notification is being done by Horry County Schools for the purpose of keeping you informed on this very important State Department of Education initiative and the requirement under South Carolina law for local school districts to implement comprehensive health education programs, and provide annually age-appropriate instruction in sexual abuse and assault awareness and prevention to all students in four-year-old kindergarten through twelfth grade.

Queridos padres:


En el año 2014, el Estado de Carolina del Sur aprobó la Ley 293 conocida como "Ley de Erin", como parte de la educación en salud y seguridad para sus escuelas públicas. El propósito de la ley es asegurar que todos los estudiantes, pre-kindergarten hasta la escuela secundaria, reciban esta instrucción de prevención durante el año escolar académico. La intención de la Ley de Erin es darles a los estudiantes habilidades para saber cómo mantenerse a salvo de las agresiones sexuales y cómo denunciar cualquier incidente de agresión sexual.

El Departamento de Educación de Carolina del Sur creó las unidades de instrucción de la Ley de Erin en apoyo de la nueva legislación que enmendó la Ley de Educación Sanitaria Integral. El Código de Leyes de Carolina del Sur La Sección 59-32-20 (B) fue enmendada para leer que la Junta Estatal de Educación a través del Departamento de Educación de Carolina del Sur "seleccionará o desarrollará unidades de instrucción en abuso sexual y prevención y prevención de agresiones, apropiadas para cada nivel de edad, desde el jardín de infantes de cuatro años hasta el doceavo grado".

La notificación de los padres está siendo hecha por las Escuelas del Condado de Horry con el fin de mantenerle informado sobre esta muy importante iniciativa del Departamento de Educación del Estado y el requisito bajo la ley de Carolina del Sur para distritos escolares locales implementar programas de educación de salud integral, En el abuso sexual y la conciencia de asalto y la prevención a todos los estudiantes en el jardín de infantes de cuatro años de edad hasta el doceavo grado.
