### Halloween at Pennock Friday, Oct. 30th

Our Collaborative Advisory Team has agreed to host Halloween this year in the following manner:

- Students grades Pre School 5th Grade have the option to come to school wearing a Halloween Costume for the day. There will <u>not</u> be time allowed to put costumes on at school so plan accordingly.. We must keep cohorts separate and do not have space available in bathrooms to accommodate changing at school. Students may bring individually wrapped (purchased) snack treats/candy that they are able to carry into school during morning lineup. Classroom parties will be held from 2:30-3:15 PM. AM and PM Preschool will have parties the last 45 minutes of their sessions.
- Sorry--Non-essential visitors (parents/guests) are NOT allowed in the building for parties or to drop items off due to social distancing guidelines. There will not be a parade for the same reason.
- Alternate space/activities will be provided for students who do not celebrate Halloweeen. Students may come in regular school attire.
- Halloween masks do not replace Covid masks. Covid masks must be worn, so heavy makeup is discouraged for student comfort. No weapons real or facsimile may be brought to school. If they are, they will be confiscated for parent pick up at a later time and are subject to disciplinary action. Be safe and keep unnecessary items at home.
- Please make sure students have appropriate indoor/outdoor shoes with their costumes
