2022-23 Promotion Information for Eighth Grade Students Academic and Behavioral Responsibilities

In conjunction with the District rules and regulations on student behavior and, in an effort to make promotion to high school and the activities surrounding it more meaningful, each member of the eighth grade class needs to be aware of and comply with the following requirements. Any student who fails to comply with these requirements may be excluded from promotional exercises, eighth grade activities and/or have grades and the Certificate of Promotion withheld.

#### **GENERAL**

- 1. Eighth graders are students of this school and are under the jurisdiction of the PYLUSD through the completion of all end-of-year activities. All discipline policies, rules, and regulations are in effect until the completion of Promotion activities.
- 2. In order to participate in the promotional and end-of-year activities, all eighth graders must complete the required course of study and have a satisfactory attendance record. Any one, or combination, of the following circumstances may result in exclusion from promotional activities:
  - A. Six (6) or more failing grades in core academic classes during the entire academic year.
  - B. A decision to retain in eighth grade, based on the district retention policy
  - C. Continuous and/or serious disciplinary concerns
  - D. Placement on "Exclusion List", with parent contact
  - E. Irregular attendance/multiple unexcused tardies
  - F. Multiple citizenship grades of N or U
- 3. Any member of the eighth grade class who participates in activities which result in suspension may be excluded from eighth grade activities and/or the Promotion exercises.
- 4. Student must be in attendance at school the day of any scheduled 8<sup>th</sup> grade activity/event in order to participate in that event.

#### LIBRARY, TEXTBOOK, AND EQUIPMENT CHARGES

All library books, textbooks, and equipment must be returned or payment must be made for all missing items. It is the responsibility of each eighth grade student to clear any charges **PRIOR** to the Monday preceding Promotion. Eighth grade students with school debts will not receive their yearbook or be allowed to participate in the eighth grade activities and/or Promotion exercises.

#### DRESS CODE

In support of District Promotion guidelines, students shall dress in a manner appropriate for an **informal** public program. The **school dress code** will be enforced at the daytime Promotion Ceremony (see attached).

#### PROMOTION BEHAVIOR EXPECTATIONS

- 1. Any student in possession of a vaping device, or under the influence of, alcohol or any controlled or lookalike substances (drugs) during any eighth grade activity or the promotional exercises will immediately be suspended and removed from the activity.
- 2. The Promotion exercise is a serious event. Students/Parents are not to bring any items which may cause a disruption or detract from the dignity of the exercise. Balloons, confetti, food and drinks are <u>NOT</u> allowed in the venue. Items will be removed. Students who violate this requirement may be excluded from the activity. It will also result in the holding of grades and promotion certificate. <u>Students should</u> not have their cell phone with them during the Ceremony.

#### 2022-23 Promotion Information for Eighth Grade Students

#### YLMS Dress Code -

Placentia-Yorba Linda Unified School District School Board Policy establishes that students shall wear appropriate clothing and footwear and groom themselves for school in a manner that does not discriminate against participants in, or substantially disrupt, the educational program. The administration and staff believe that dress affects the academic environment at school and, in some cases, can be disruptive to the learning environment. Therefore, the dress code applies at all times to students while on campus or in attendance at any school event.

The following items are examples and not intended to be a complete list of rules regarding dress:

• Clothing, jewelry and personal items (backpacks, fanny packs, gym bags, water bottles etc.) shall be free of writing, pictures or any other insignia which are crude, vulgar, profane or sexually suggestive, which bear drug, alcohol or tobacco company advertising, promotions and likenesses, or which advocate racial, ethnic or religious prejudice.

• Clothes shall be sufficient to conceal undergarments at all times. See-through or fish-net fabrics, halter tops, off-the-shoulder or low-cut tops, bare midriffs and skirts or shorts shorter than mid-thigh are prohibited.

- Pants must be worn near waist level; oversized clothing is unacceptable.
- Outer clothing must be in good repair.
- Shoes must be worn at all times. No open toed shoes allowed. All shoes must have a back.
- All decisions regarding interpretation of dress code will be determined by administration.

#### PYLUSD Dress Code EC Section 35183 -

Students must wear appropriate clothing, footwear, and accessories, and must groom themselves for school in a manner that supports standards of safety, does not offend common standards of decency, does not reflect negatively on, or detract from any phase of the educational program, and does not indicate a relationship to unauthorized student groups. School dress codes do allow for the outdoor use of sun-protective clothing (e.g., hats, etc.). These guidelines apply during the school day and at school sponsored activities conducted on or off campus outside the official school day. Principals will publish specific statements and guidelines developed by their staff, students, and community. The Education Code authorizes school districts to adopt a dress code policy that would require students to wear a school-wide uniform.

<u>**Girls:</u>** Girls should wear an age-appropriate dress, skirt, or dress pants. The top (or top of dress) should meet YLMS student dress code guidelines in the student handbook. <u>**NOT PERMITTED**</u> at the ceremony or the event are backless, sheer, low-cut, off the shoulder, or strapless tops, long / short formal or evening attire, skirts with revealing slits, mini-skirts, shoes with heels, or backless shoes. Dresses should not be too tight or short (thumb-length rule).</u>
