Time and Place for Filing Sealed Proposals. Sealed bids for the work comprising the repair or improvement as stated below must be filed before 11:00 AM on June 28, 2022, in the office of the City Clerk, 201 Center Street, PO Box 296, Lime Springs, IA 52155.

Time and Place Sealed Proposals Will be Opened and Considered. Sealed proposals will be opened and bids tabulated at 11:00 AM on June 28, 2022, in the office of the City Clerk, City of Lime Springs, 201 Center Street, PO Box 296, Lime Springs, IA 52155 with the results being reported to the City of Lime Springs at its meeting at 7:00 PM on July 5, 2022, at which time the City Council may take action on the proposals submitted or at such time as may then be fixed. The City of Lime Springs City Council reserves the right to reject any or all bids, to waive informalities or technicalities in any bid, and to enter into such contract, or contracts, as it shall deem to be to the best interest of the City of Lime Springs.

Time for Commencement and Completion of Work. Work on the improvement shall commence upon approval of the contract by the City Council and as stated in the Notice to Proceed. All work under the Contract for Lincoln Street (A23) must be substantially complete on or before 09/30/22. All work under the Contract for Jackson Street must be substantially complete on or before 11/18/22. Liquidated damages as set forth in Section 00500 - Contract.

Bid Security. Each bidder shall accompany its bid with bid security, as defined in Iowa Code Section 26.8, as security that the successful bidder will enter into a contract for the work bid upon. The bidder's security shall be in an amount equal to 10 percent of the total amount of the bid. The bid shall contain no condition except as provided in the specifications.

If the bidder fails to execute the contract and to furnish an acceptable performance, payment, and maintenance bond or provide a Certificate of Insurance within ten (10) days after acceptance of the bid by the City, the bid security may be forfeited or cashed by the City as liquidated damages.

Contract Documents. Copies of the project documents are available for a price of \$25 per set. This fee is refundable, provided the plans and specifications are returned complete and in reusable condition, and they are returned within fourteen (14) calendar days after the award of the project. Preference of Products and Labor. By virtue of statutory authority, a preference will be given to products and provisions grown and coal produced within the State of Iowa, to the extent lawfully required under Iowa statutes.

Sales Tax Exemption Certificates. The bidder shall not include sales tax in the bid. The City of Lime Springs will distribute tax exemption certificates and authorization letters to the Contractor and all subcontractors who are identified. The Contractor and subcontractor may make copies of the tax exemption certificates and provide a copy to each supplier providing construction materials. These tax exemption certificates and authorization letters are applicable only for this specific project under the Contract.

PROJECT DESCRIPTION: Street and utility reconstruction of Lincoln Street (A23) from Howard Street to Merrill Street and West Jackson Street from Forest Street to Clark Street. Work includes approximately 700 LF of sanitary sewer, 1700 LF of watermain, 240 LF of storm sewer, and 2400 SY of PCC.
