

NOTICE TO BIDDERS

CITY OF LE GRAND PUBLIC IMPROVEMENT PROJECT

Notice is Hereby Given:

Sealed proposals will be received at the office of Clapsaddle-Garber & Associates located at 16 E. Main Street, Marshalltown, Iowa 50158, for the work comprising of the improvements and must be filed before **10:00 A.M.** local time according to the clock in the office of Clapsaddle-Garber and Associates on **April 11th, 2023** for the improvements, as hereinafter described in general and as described in detail in the Plans and Specifications for said improvements now on file at the office of Clapsaddle-Garber & Associates or the City Clerk. Proposals will be opened by the City and Clapsaddle-Garber & Associates at a later time and will not be open to the public. Bid tabs will be made available to contractors following the bid opening.

Proposals will be acted on by the City of Le Grand at a meeting to be held at the Monet Center at 206 N. Vine Street, Le Grand, Iowa 50142, at **7:00 P.M local time on April 11th, 2023**, or at such later time and place as may then be fixed. The City of Le Grand reserves the right to award the Contract at the time of said meeting or at such later time may then be fixed and to reject any or all bids and to waive technicalities and irregularities and to enter into such Contract as it shall deem to be for the best interests of said Owner.

The extent of the work involved is as follows: **Intersection pavement removal and replacement with PCC at the intersections of; Main & Vine, Main & Prairie and pavement removal and replacement of Julian Street from Manor Road to Sheri Street. The Contract also includes the removal and replacement of two (2) sidewalk ramps at Vine Street and Main Street. The Contract also includes four (4) Alternates, which include #1: constructing Julian Street with HMA instead of PCC; #2: crack cleaning and sealing on streets of Grandview Drive, Willow Lane, and Franklin Street; #3 Reconstructing the City Hall parking lot and sidewalk with PCC; and #4: Reconstructing the City Hall parking lot with HMA instead of PCC**

Contract Time

The work under the contract shall actively commence within ten (10) days upon issuance of the Notice to Proceed following the Preconstruction Meeting upon signage of contracts. The early start date for the overall project shall be **May 15, 2023** with the first pay application being issued in June 2023. Due to Little League usage of the baseball/softball field along Julian Street, the early start date for the removal/replacement of Julian Street shall be at the conclusion of the season(s) – approximately **July 10th, 2023**. All other portions of the project excluding Julian Street can be started and worked on between May 15th and July 10th of 2023.

Once the project has commenced, the project shall be completed by **September 1st, 2023**. This project is subject to liquidated damages as described within the project manual. The Notice to Proceed shall be issued at a preconstruction conference to be held at a future determined date after a fully executed contract.

Bid Security

Each proposal must be accompanied with a bid security as defined in Iowa Code Section 26.8, as security that the successful bidder will enter into a contract for the work bid upon and will furnish after the award of contract a corporate surety bond, in a form acceptable to the Jurisdiction, for the faithful performance of the contract, in an amount equal to 100% of the amount of the contract. The bidder's security shall be in the

amount fixed in the Instruction to Bidders and shall be in the form of a cashier's check or a certified check drawn on an FDIC insured bank in Iowa or on an FDIC insured bank chartered under the laws of the United States; or a certified share draft drawn on a credit union in Iowa or chartered under the laws of the United States; or a bid bond on the form provided in the contract documents with corporate surety satisfactory to the Jurisdiction and filed in an envelope separate from the one containing the proposal, made payable to: Treasurer, **City of Le Grand**. Said check or draft may be cashed or the bid bond declared forfeited by the Treasurer as liquidated damages in the event the successful bidder fails to enter into a Contract within fourteen (14) days and post bond satisfactory to the Owner insuring the faithful fulfillment of the Contract and maintenance of said improvements as required by law and the Specifications. The bid shall contain no condition except as provided in the specifications.

Award of Contract

Bidders shall not be permitted to withdraw their bids for a period of sixty (60) days after the date set for opening bids. The Owner reserves the right to reject any and all bids and to waive any informality in the bids received in the best interest of the Jurisdiction.

Bonding Requirements

The successful bidder will be required to furnish a performance and payment bond in the amount equal to 100% of the contract price at the time of contract execution.

Each successful bidder will be required to furnish a corporate surety bond in an amount equal to 100% of its contract price. Said bond shall be issued by a responsible surety approved by the **City of Le Grand** and shall guarantee the faithful performance of the contract and the terms and conditions therein contained and shall guarantee the prompt payment of all material and labor, and protect and save harmless the **City of Le Grand** from claims and damages of any kind caused by the operations of the contract and shall also guarantee the maintenance of the improvement caused by failures in materials and construction for a period of two (2) years from the date of final acceptance of the work under the Contract.

Additional Provisions

Modification to the project documents may only be made by written addendum as issued by the Owner or Owner's authorized Representative. The bidder's proposal must be made on the forms provided within the bound project manual. Bidders must supply all required information prior to the time of bid opening. The **City of Le Grand**, in accordance with Title VI of the Civil Rights Act of 1964, 78 Stat. 252, 42U.S.C. 2000d to 2000d-4 and Title 49, Code of Federal Regulations, Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Nondiscrimination in Federally-assisted programs of the Department of Transportation issued pursuant to such Act, hereby notifies all bidders that it will affirmatively insure that in any contract entered into pursuant to this advertisement, minority business enterprises will be afforded full opportunity to submit bids in response to this invitation and will not be discriminated against on the grounds of race, color, or national origin in consideration for an award.
