

NOTICE TO BIDDERS & NOTICE OF PUBLIC HEARING

CITY OF WESTFIELD WESTFIELD, IOWA NEW WELL NO. 4

General Notice

The City of Westfield, IA (Owner) is requesting Bids for the construction of the following Project:

WESTFIELD WATER SYSTEM IMPROVEMENTS NEW WELL NO. 4 DWSRF No. FS-75-22-DWSRF-035

Bids for the construction of the Project will be received at the **Office of the City Clerk** located at **223 Union St, Westfield, IA 51062**, until **Wednesday, March 20th, 2024**, at **1:00 PM** local time.

The Project includes the following Work:

1. Remove and stockpile playground equipment as needed for well construction.
2. Construct new well and perform all required testing.
3. Install pitless adapter and raw water main piping and appurtenances.
4. Restore site to original conditions with positive drainage within 15 feet of the wellhead.
5. Install electrical items.
6. Reinstall playground equipment following well construction completion.
7. All other work shown on Drawings or called for in Specifications.

The Owner will meet in the Council Chambers at 223 Union St., in said City, on the **Monday, March 25th, 2024, at 6:15 PM**, at which time and place a hearing will be held on the proposed plans and specifications, form of contract and estimate of cost for the Project. At that time, any interested person may appear and file objections to the proposed plans, specifications, form of contract and estimated cost of the Project.

Sealed bids will be opened and tabulated at **1:00 PM**, on **March 20th, 2024**, in the Council Chambers at City Hall, 223 Union St., Westfield, Iowa. The bids will be considered by the Westfield City Council during their meeting beginning at **6:15 PM**, on **March 25th, 2024**, in the Council Chambers at City Hall.

All bids must be filed in the office of the City Clerk before the time herein set, on forms furnished by the Owner, and must be enclosed in a separate sealed envelope and plainly identified. Each bid shall be accompanied by bid security as defined in Iowa Code Section 26.8, and in the amount of 10% of the total amount of the bid, as specified in the Bidding Documents, as security that if awarded a contract, the bidder will enter into a contract at the prices bid and furnish the required performance and payment bonds and Certificate of Insurance.

Each successful Bidder will be required to furnish Performance and Payment Bonds acceptable to the Owner on forms provided in the specifications in amounts equal to one hundred percent (100%) of the contract price.

Work on the improvement shall commence within 30 days after the Effective Date of the Contract, or on the day indicated in the Notice to Proceed. The Notice to Proceed will be issued upon approval of the contract and bonds by the City Council. The work shall be substantially completed on or before **October 15, 2024**, and ready for final payment in accordance with Paragraph 15.06 of the General Conditions on or before **December 15, 2024**. Failure to meet either the Substantial Completion dates or Final Completion date will result in liquidated damages of **\$500.00** per calendar day.

To the extent allowed by Federal law and regulation, and to the extent required by Iowa law, a resident bidder shall be allowed a preference as against a nonresident bidder from a state or foreign country if that state or foreign country gives or requires any preference to bidders from that state or foreign country, including but not limited to any preference to bidders, the imposition of any type of labor force preference or any other form of preferential treatment to bidders or laborers from that state or foreign country. The preference allowed shall be equal to the preference given or required by the state or foreign country in

which the nonresident bidder is a resident. In the instance of a resident labor force preference, a nonresident bidder shall apply the same resident labor force preference to a public improvement in this state as would be required in the construction of a public improvement by the state or foreign country in which the nonresident bidder is a resident. Failure to submit a fully completed Bidder Status Form with the Proposal may result in the Proposal being deemed nonresponsive and rejected.

The Owner hereby reserves the right to reject any or all bids, to waive informalities and irregularities, and to enter into such contract or contracts as it shall deem to be in the best interest of the City.

By virtue of statutory authority, a preference will be given to products and provisions grown and coal produced within the state of Iowa.

All official notifications, addenda, and other Bidding Documents will be offered only through the designated website.
